## When Doubts Assail

Those Days of Awe we now approach will serve us best if they bring new doubts to the surface, doubts to be honorable, confronted, and, in the true spirit of Rosh Hashana and Yom

Kippur, earnestly prayed over.
For who now, taking note of progress through propaganda made by Israel's foes during the year closing, can cross the threshold of the New Year confident that war will be averted in the Middle East? And if war does not strike, how does a severely maligned nation deal with the power play in the United Nations, mounted to achieve Israel's ouster from those halls, erected in comity and dedicated to the tireless, unending search for peace?

Beyond sorrowful meditation on the danger

facing Israel, the wrath directed towards her by leaders of the Third World, Arab, Communist. and African blocs, we are now in the presence of doubts arising from political and economic ferment in countries torn by conflict: India, where Mrs. Ghandi's opposition is muzzled; Portugal, where a marriage between the military and rigid left is crowding out freedomloving socialists; Uganda, where a Hitler-adoring Marshal Idi Amin undercuts international conventions and crushes critics; and Argentina where the second Mrs. Peron chases breathlessly after her government careening towards collapse. Never have so many national establish-

we are commanded at High Holiday time to pray that tyranny will pass away, carrying its wicked trappings with it. Surely, in this dangerous era, the need for such prayers is more clearly evident than ever.

And if we lacked for other centers of hard-

heartedness and oppression to pray over, we would remain obliged to raise our voices in prayer for the Jews in the Soviet Union. Shocked by the new confiscatory 30% tax the Kremlin is saddling on funds sent to individuals and troubled by Moscow's sharp resistance to American efforts to combine trade with assurance of the right of exit, we now find ourselves praying during these Days of Awe for renewal and continuity of cultural rights for Soviet Jews. If emigration is halted, must participation in the rituals of a proud heritage be crushed also?

In the course of sifting through our doubts in the holy season we turn to the domestic scene also. From academe, in the dying weeks scene also. From academe, in the dying weeks of the Old Year, word has gone out that if the campaign for Affirmative Action doesn't do in the American Jewish community, then the nounting rate of intermarriage will. These are not related issues. We mention them simultaneously because some folks seem to have become ac-quainted with these developments only when our deep thinkers point them up. As to Affirmative Action -- a summons to stretch the guarantee of equality of opportunity to a breaking point --the Jewish community of America has fought too long and too successfully ever to succumb to a new fangled quota system. As to intermarriage (one in every three American Jews now marries outside the Jewish religion), we must have confidence that the continuity of our faith, the treasures it bestows on its adherents, and the resiliency it has displayed through the ages will keep us whole, intact, undissolvable.

This old anvil -- the Jewish mystique -- has

broken many hammers. It cannot be shattered. But praying over it in this season blessed by prayer is definitely in order,

#### AJC PRESIDENT SEES UN DANGER TO ISRAEL

NEW YORK -- In a message marking the Jewish New Year 5736, commences which Friday evening, Sept. 5, Elmer L. Winter, 5, Elmer L, President of Tewish American Committee. expressed hope for an peace in the Middle East but saw danger to Israel and the West in the efforts to expel Israel from

the United Nations, "The State of Israel and her neighbors would appear to be closer to understanding and agreement than they have been in many years. Mr. Winter said, "We fervently pray that they may soon meet in accord, and reach an arrangement that will enable all the people of the Middle East to turn their energies to constructive actions and peaceful pur-

Those who seek to oust Israel from the United Nations, Mr. Winter said, not only threaten Israel also "Western countries, including our own, that had hoped to establish the United Nations as a world forum, where responsible sovereign states would together pursue the cause of

peace,"
It is time, he said, that "this important international body returned to the concepts of its founders,

In his statement, Mr. Winter called attention to "the continuing harassment of our Jewish brethren in the Soviet Union," and to the plight of the Jews still living in Syria, "We are determined," he said, "to redouble our efforts to bring these inhuman acts before the court of world opinion."

Turning to domestic concerns, Mr. Winter expressed optimism that the would achieve nation economic stability and would create meaning-ful social programs "to return this country to the high standards it nerits.


### CHARGES COMMERCE DEPT. AIDING BOYCOTT

NEW YORK (WNS) U.S. Department of Commerce has been accused by the Anti-Defamation League of B'nai B'rith with "cooperating & assisting" the Arab boycott op-erations against Is-

ADL national chair Seymour Graubard in a letter of protest to Commerce Sect'y Roger Morton charged that in a letter by the Dept.'s of Business Research and Analysis there was a statement from Iraq that firms bidding to sell 3500

pre-cast buildings to that Arab country should not use "any material manufactu-red in Israel or by companies boycotted officially by Iraqi Government," The ADL said it was told by the Commerce Dept, that 'it is routine practice' to send out such notices.

Graubard in his letter noted that the Commerce Dept, has been warning American Companies that they must report requests for boycott compliance,
