HERZOG URGES STRONGER US ROLE IN U.N.

in the United Nations, Chaim Herzog, Is-rael's Ambassador to the UN, declared at conference on "Israel and the United Nations" sponsored by the Synagogue Council of America, Herzog said that the American indifference to the UN over the past several years has hurt the world organization and has been bad for Israel. He said, how-ever, there is a ever, there is sign that American attitude is changing.

Herzog also scored the anti-Israeli resollutions adopted by the Organization of African States in Kampula, Uganda and the nonaligned conference in Lima, Peru, as an "unbelievable concentration of vili-fication, hate and fication, hate and baseless vituperation against Israel and the Jewish people,"

WASHINGTON (WNS) --Secretary of State Henry A. Kissinger has begun efforts to win massive American support to the U.S. participation in the Israel-Egyptian agreement including the sending of American technicians to the Sinai and U.S. aid for Israel and Egypt. Appearing before the House International Rela-

tions Committee, Kissinger warned that " "The process of peace in the Middle East is not a matter that occurs thousands of miles away but which affects every American. The agreement could open the way to peace in the whole area." Kissinger stressed that the total number of

Americans sent to Sinai will not be more than 200 and no more than 75 would be at the monitoring stations at one time. The technicians, he em-phasized, will not be there to serve one side or the other "in contrast to Vietnam." He stressed while both Egypt and Israel wanted the technicians, Israel would not sign the agreement if they will not be sent there.

At a press conference, Kissinger minimized the Palestine Liberation Organization threat to shoot the American monitors, noting that the Americans would be between Israel and Egyptian forces, and surrounded by United Nations troops. He said the Administration would decide soon whether the technicians would be provided by a private organization or the American government, stressing that it will definitely not be under the Department of Defense. Rep. Bella S. Abzug (D. NY) said she is forwarding to the State Department inquiries from women who would like to serve as American monitors in the Sinai.
