The world Jewish "summit" which was held in Jerusalem last week was a reaction to the United Nations General Assembly resolution linking Zionism with racism as well as the other anzi-Zionist resolutions of the current Assembly session. Yet the conference had limitations since what could it really do, much more than could have been accomplished without having 170 Jewish leaders from throughout the world meeting in Jerusalem with their Israeli counterparts

Having more than 300 persons at the conference makes it hardly possible to have a really effective debate. The people who at-tended are committed people closely identified with support for Israel. But that was the prob-lem. As one American Jewish leader put it "This is preaching to the converted. The peo-ple here are all committed, all Zionists, all Israel-lovers, all doers..." Arthur Hertzberg, president of the American Jewish Congress pointed out, were half of the Jewish people, those who do not belong to organizations

The problem before organized Jewry is how The problem before organized Jewry is now to raise the consciousness of the uncommitted Jews, many of whom are ready to help if they are shown how. Also necessary is to show the justice of larael's cause to people and govern-ments, either indifferent or hostile. No one can fault the proposals made at the "summit" conference. bly reaffirm the legalization of the murderous PLO and on the selfsame day equate Zionism with racism in the Hitlerian style, this December witnessed the 'mighty' Security Council place its seal of approval on a resolution that opened its 'sacred' doors to Yasir Arafat's gang and at a subsequent meeting condemn Israel on her retaliation against this bomb - throwing gang in the PLO 'refugee-protected' nests in Lebanon. Adding insult to injury, the Assembly's Special Political Committee at the same time busied itself in placing special emphasis on alleged Israeli violations of human rights in the occupied areas as based upon a biased report sub-mitted by a three-nation anti-Israeli "special committee to investigate Israeli practices affecting human rights.

No wonder Ambassador Chaim Herzog, after all this unrelenting anti-Israeli barrage, lashed into the world organization and charged it with devoting more than "thirty per cent of its time to an endless procession of charges and accu-sations against the State of Israel " sations against the State of-Israel.

Ascending the Assembly rostrum in a combatant mood in the full realization that he was facing a majority of hostile delegations, Herzog spoke out in unmistakable terms. "The manner in which the General Assembly is dealing with the Middle East problem," he stated, "is a tragedy of major international proportions. Its implica-tions are terrifying and sinister. This forum should be acting as one whose purpose is to encourage negotiations, to strive for consensus and compromise ...

"Instead," Herzog declared, "this body, by allowing itself to be dominated by a group of intransigent extremists, whose declared purpose to fight against any move toward peace, is encouraging dissent instead of accord, intrasi-gence instead of compromise, fanaticism instead of accommodation and conflict instead of peace...


"When this organization has disappeared in infamy into the limbo of history," he continued, "historians will recall that the process began as soon as it allowed itself to depart from the original lofty purposes for which it was created, and to become an instrument for those who would block the road to peace in the Middle East.

"You can move from committee to committee today, and you will discover that this obsession with Israel, which has been imposed upon you, has become a mania which has by now perverted this organization into the sorry picture which it presents to the world and has turned into a

body which is rapidly losing any vestige of credibility in the eyes of decent people." In referring to the 'big lie' which the Arabs and Soviets along with their 'bought' friends have been proclaiming as a truth, the Israeli Ambassador indignantly stated that "it is time we exploded the myth about Israeli agression in 1967 once and for all. Let me nail it down for the blatant lie and untruth that it is," he said as he continued to set the record straight. "We were threatened with annihilation.... The move-up of the Arab armies was in full view of the world. The UN forces were expelled ignominiously. We were left on our own, and we were left to protect our lives and the lives of our schildren and wives. We did not seek aggression.

The PLO is an alliance of terrorist organizations, dominated by the largest of the groups, the Soviet-armed Fatah. Hundreds of Israelis Europeans and Americans have been murdered by the PLO since 1967. Remember the Swissair jet bombing that killed 47? Remember the Lod Airport massacre, where 21 Americans died along with others? Then there was the murder of II Israeli members of the Olympic team and the executions of U.S. Ambassador Cleo Noel and his aide along with the Belgian diplomat. And how about the 24 children slaughtered at Ma'alot? These and a thousand diplomat. other acts of terror were launched against un-armed civilians, for which the PLO claimed credit.

The most recent Israeli raids against the PLO headquarters were preventive -- not puni-tive. There were five targets. Nebatiga is a major terrorist base. All citizens had fled when the PLO moved in. The school building hit was deserted of children since May, 1974. It was a terrorist main office. El Foka was a jeep camp and a Fatah supply center with a missile armory, which was blown up. Masrat Tul was a general training base for fighters in Beirut. Badawi and Nahr el Bared were terrorist bases, camps and offices, which were attacked by Lebanese and Jordanian bombers not

too long ago. Last year the Arabs also claimed civilian casualties after an Israeli raid. But ABC-TV's Peter Jennings reported "damage in the civilian part was not extensive." He was not per-mitted to film the strikes against commando positions.

Once more we repeat that Israel, like the is very anxious to solve the Palestinian U.S. problem. Israel is ready and willing to negotiate with genuine Palestine leadership who will recog-nize the rights of Israel and Jordan to exist. America will understand, we are certain.
