O'CALLAGHAN, RICH CHAIR JEWISH HOSPITAL EVENT

Governor Mike O'Callaghan an Executive Charles J. Rich have accepted the posts of honorary chairmen for the 1976 Honor Award Dinner-Dance of the Las Vegas Friends of National Jewish Hospital and Research Center for Sunday, January 18 at 7 p.m. in the Colosseum Room of Caesars Palace.

The coveted third annual Award will be presented to Met Exber president and general manager of the Las Vegas Club Hotel and Casino, who is being honored for "his distinguished contributions and

humanitarian efforts on behalf of Nevada as well as his dedicated service to National Jewish Hospital," said Jackie Gaughan, dinner chairman and president of the El Cortez Hotel.

Nevada residents of all faiths have received over 7,000 days of care at the Denver hospital regardless of race, age or ability to pay if afflicted with asthma, emphysema, tuberculosis, cystic fibrosis, allied chest ailments or immunological diseases. "Because the Hospital does not duplicate any local facilities, many

Nevada doctors send their hard-to-treat patients to this famed 'medical court of last resort.'" Gaughan explained, adding that almost one-third of all patients are children.

Rich received the second Honor Award last year and O'Callaghan was the honoree the first year. Both have been active supporters of the Hospital as well as vigorous participants of many other philanthropies. Rich recently was named a National Trustee of the world-famed National Jewish Hospital.

All proceeds from the \$200-per-couple Dinner-Dance will help NJH continue its life-saving services to this area.
