To the Editor:

In these times when neo-antisemitism appears under the guise of fighting Zionism, it is most timely to learn that the Dr. Reuben Hecht Chair for the Study of Zionism has been funded at the University of Haifa. I have accepted the position of Academic Advisor on the American scene to oversee this program and am asking for assistance in the following areas:

A great many manuscripts, documents, and Jewish newspapers of the relevant period -- the period of the British regime and British Mandate in Palestine (1917-1948) may be in the possession of private individuals who are not making use of them (often this type of material was left by parents who died and is being kept for sentimental reasons). It would be of great assistance to those engaged in this important research if owners of such material, as well as of back copies of "New Palestine" and other such journals, would contribute those items to the archives being compiled under the Chair of Zionism at the University of Haifa. Such resources would greatly increase the scope and depth of this project.

This is the first and only Chair dedicated to studying the origins of Zionism, its socio-economic background, its political struggles and all the other aspects of human interest related to this movement of national liberation. Any assistance and cooperation in this endeavor will be greatly appreciated.
