MARTIN LUTHER KING FOREST IN ISRAEL

WASH. (WNS) -- Funds to plant 10,000 trees and create a Dr. Martin Luther King Jr. Memorial Forest in Israel are more than half subscribed, according to Max Kampelman, head of the committee.

The committee which is made up of representatives of Jewish organizations in the Washington area includes every Black and Jewish member of Congress. Dr. King once said of Israel: "Israel is one of the great outposts of democracy in the world, and a mar-

velous example of what can be done, how desert land can be transferred into an oasis of brotherhood and democracy."

CARLISLE, PA. (WNS) -- The B'nai B'rith Hillel facility at Dickinson College here not only serves students and faculty but also has become a "Jewish address" for the 30 Jewish families living in Carlisle.

Carlisle Jews to travel to Harrisburg for the nearest Jewish institution.
