**EX-SENATOR, WHO FAVORED ARABS, ON PAYROLL**

WASH. (WNS) -- Former Senator J. William Fulbright has registered as a foreign agent with the Department of Justice.

The former chairman of the Senate Foreign Relations

Committee is representing the United Arab Emirates, a federation of oil-producing sheikdoms on the Persian Gulf. Through Fulbright's efforts, the United Arab Emirates engaged Fulbright's law

firm, Hogan and Hartson, as its legal counsel.

Meanwhile it was reported from Cairo that Fulbright has been awarded Egypt's Order of the Republic, the country's second highest award, in recognition of his support for the Arab cause. President Anwar Sadat reportedly praised the Arkansas Democrat as the first American official to recommend the U.S. recognize the Palestine Liberation Organization.

NEW YORK -- This year's "Annual Study Day" of the Women's League for Conservative Judaism on February 18 will feature two young women scholars who will discuss the comparisons and contrasts in judicial processes as they existed in the Talmudic period and those used today in both criminal and civil cases in American constitutional law.
