## The 'New Jews'

Dr. Emil Fackenheim, the eminent philosophy professor at the University of Toronto, has charged the Soviet Union and the Arab states with the "systematic theft of the Holocaust" from the Jewish people.

He claimed they are saying: "The Israelis are the new Nazis; the Palestinian Arabs are the new Jews; the Palestine Liberation Organization is the French freedom fighters and Zionism is racism." Fackenheim said the plot which was launched by the Soviet Union when it called Israelis Nazis at the United Nations following the 1967 Six-Day War, was picked up by the Arabs culminating in the UN resolutions equating Zionism with racism.

The attempt to equate Israel's treatment of the Palestinians with the Nazi extermination of the Jews is obscure. There are no concentration or death camps in Israel. Israel has never even executed a captured terrorist. Arabs in Israel, while undergoing some restrictions, mostly live peacefully and have done well economically since the creation of the State of Israel. The same holds true for the Arabs in the occupied territories.

The Arab refugee problem is no different from refugee problems anywhere in the world following wars. The number of Arabs who have fled Israel can be equalled with the number of Jews forced to leave the Arab countries since the birth of Israel.

Yet despite all this there are many people willing to believe this propaganda. A whole generation has grown up since the Holocaust who know nothing about it and who see it no worse than other events that have happened or are happening in the world. There are also others who lived through the Holocaust and are willing to cleanse their guilt by now making the Jews the aggressors rather than the victims.

"majority" may conspire to maneuver here in conjunction with the Syrian threat not to renew the mandate of the UN force in the Golan due to expire in May, unless this world organization accepts Damascus' blackmail terms on the issue of the PLO, one thing is certain -- and the whole world knows it -- Israel remains adamant in her position not to allow the creation of a third state between her and Jordan.

A PLO entity in the West Bank, it goes without saying, would quickly be turned into a Soviet-Syrian "Trojan Horse" jeopardizing the very existence of both Israel and Jordan.

The United States -- which is learning a sad lesson in Angola and in other troublesome spots around the globe -- is fully aware of this fact and has therefore stood firm in its refusal to bend to the demands of so many UN delegations that it approve the legality and 'rights' of terrorist Yassir Arafat's Palestine Liberation Organization. Surely, there can be no compromise on the question of the PLO nor on any so-called formula upon which Washington can agree to open the door for Arafat's terrorists in any future negotiations.

Thus, no matter who will succeed Daniel Patrick Moynihan (even if it be President Ford's choice of William M. Scranton), Israel's staunch champion here -- who had rocked this UN glass and marble structure to its very foundations by his outspokenness and by the fact that he had laid bare for all the world to see the guilt and depth of depravity of so many delegations who had made a mockery of the Charter principles adopted at San Francisco -- U.S. policy vis-a-vis Israel and the Arabs will undoubtedly remain unchanged and the new Ambassador is certain to continue in the bold and dynamic path paved by the 48-year-old Irish American, President Ford made this crystal-clear when, in discussing the succession to the UN post, he vowed that Moynihan's successor would "follow the same policy of challenging some of the third or fourth world powers, calling a spade a spade."

Moynihan had employed a language which America's and Israel's foes understood only too well. By his singular veto invalidating the pro-PLO resolution these foes along with some 'friends' realized that they could not have it their own way all the time and that they better take heed as to their future actions.

Indeed, the impact of the Moynihan episode is still to be fully felt. By spotlighting the UN's weaknesses and scoring its shortcomings, he served warning to the General Assembly and the Security Council that in all their future deliberations they will have to contend with a U.S. policy based not on onesidedness and recriminations but on the principles embodied in the Charter which they have pledged to uphold.

As one observer here put it: Moynihan's "success in putting the world organization back on the map is regarded not only by his very few admirers but even by his many foes at the UN as one of his important contributions.... When he arrived in the middle of last summer, Secretary - General Kurt Waldheim's domain was dangerously low in the estimation of both the press and the public, at least in the Western world..."

Accepting President Ford's request that he remain through the month of February as presi-

would not comment on matters before the court...." and then proceeds to do so, he is a bare-faced liar, a dishonest commentator and a disgrace to respectable human beings.

And just what was the occasion for Greenspun's vile outburst?

Lionel, Sawyer and Collins, representing Howard Hughes (Summa Corp.) asked two justices to disqualify themselves from rendering a decision on a motion brought by Hank Greenspun. Everyone in Nevada is fully aware of the friendship between the two justices and Hank. The request by Lionel is perfectly normal in legal procedure and it is usually made in the judge's chamber. Each of the justices had removed themselves on numerous occasions and one excused himself on the very next day in another matter.

Greenspun wrote his ugly piece because he said it concerned the integrity and judicial process and is a matter of public concern and civic duty....to inform the public on matters which are in their best interest. All this is to bull....his readers because it is not the public but Greenspun himself, who has the sole and only interest in the outcome of this particular suit. Of course the public is interested in seeing that justice prevails in all our courts, which handle tens of thousands of civil suits annually. But an honest writer, seeking to inform the public would choose any other court action as an example, not one in which he was personally involved.

It is sickening for Greenspun to justify his abominable performance in the guise of a public service. The public is not concerned with the actions of lawyers. We have every faith in the ability of jurists to cope with the demeanor in their courts. There was not one iota of public service in Greenspun's deliberate abuse to his readers. It was strictly self-serving.

Greenspun again lied when he stated he prefers to accept wire service reports of activities (in which he is personally involved) "and thus remain totally objective and uncontaminated in my stewardship of ---(the Sun.)" The full wire service report, without the invectives, was printed in his paper the previous day.

Greenspun went on to insult the intelligence of his readers by stating: "I will attempt to treat it as subtly and dispassionately as is humanly possible." Calling reputable citizens like Lionel, Sawyer and Collins "a group of hired guns," and "the assassins" is hardly being subtle or dispassionate.

Practically everybody in Nevada knows by now that Greenspun is attempting to evade repayment of a \$4,000,000 loan in cash from Howard Hughes. It was made in 1967 at the ridiculous rate of three percent interest, to be repaid in half million dollar installments by 1974. Named as collateral for the loan was property in Paradise Valley and the L.V. Sun stock. It was agreed the deed would not be recorded.

Subsequently, a second deal was made involving the transfer of lands in Paradise Valley to Hughes interests. A second note was actually drawn which extended payments on the first note to the year 2004. But Summa contends Greenspun never complied with the terms of the second note, which made it invalid.

Hence when payment on the first note became due, \$30,000 tendered by Greenspun as token interest was returned. Request was made for a half million, the first repayment on the four million. The request went unanswered. The deed was duly filed and action was commenced to recover from the collateral, the Las Vegas Sun.

Greenspun, in panic, secured a temporary injunction to restrain the takeover of his paper. The motion was heard in Ely, Nevada, where the district judge issued a permanent injunction and had Greenspun post \$15,000 in escrow with the Court.

Greenspun then commenced an action for \$142,000,000 against Hughes (Summa Corp.) claiming the filing of the deed damaged his value in the property. Summa Corp. counterclaimed
