

WEST BANK QUIET AFTER PLO INSTIGATED RIOTS

JERUSALEM (WNS) -- After weeks of disturbances the West Bank has quieted down except for minor incidents.

One of the reasons given for the cooling of tension is that Jordan is also eager to have the demonstrations stop since it, like Israel, wants the municipal elections in the West Bank held as scheduled in April. Jordan, like Israel, also does not want to see the Palestine Liberation Organization gain in influence in the area.

Meanwhile Defense Minister Shimon Peres minimized the nature and scope of the disturbances. They were "neither the first nor the worst we have faced in Judea and Samaria," he told the Knesset. He noted that the disturbances were mainly by school children and adults by and large did not participate. He said Israel will not be deterred by the PLO, the Communists or by stone-throwers.
