

### JEWISH LEADER, FORD'S FRIEND BLAMES ISRAEL

JERUSALEM (WNS) -- The current feeling of tension between the United States and Israel was generated by the Israeli press, according to Max Fisher, chairman of the Jewish Agency Board of Governors. He said this feeling was not apparent in the United States.

Fisher, a close personal friend of President Ford, told a news conference here that he would "suggest very strongly that the Israeli press handle differently the relations between Israel and the U.S." Fisher said Israel has made "too big an issue" over the sale of six C-130 transport

planes by the U.S. to Egypt.

He said the U.S. is committed to Israel's security but it is also friendly with Egypt. "Only a major power which is friendly to all sides of the Middle East conflict can try to find an agreement," he said.

Fisher also denied allegations that Ford has "written of" the Jewish vote in this year's Presidential election. "No one can give up the big Jewish population concentrations" in states like New York, Florida, California and Pennsylvania and President Ford has not, he said.
