GUSH EMUNIM ACTION CREATES SPLIT

JERUSALEM (WNS) Pressure is being mounted on Premier Yitzhak Rabin to hold a Cabinet debate on Jewish settlements on the West Bank and determine the fate of the controversial Gush Emunim encampment outside the Kadum army base in the Samaria Region.
Rabin has been de-

laying a promised session in the issue which could result in a split in his coalition government from elther the right or the left. The National Religious Party has threatened to pull out of the coalition if the Gush Emunim settlers are evicted. A fallure to evict the settlement could result in Mapam moving out of Labor Alignment well as splits within the ranks of Rabin's own Labor Party.

continues to be adamant against providing aid to Israel and other countries to cover the transitional quarter between the end of the current fiscal year on June 30 and the start of the 1977 fiscal year on October 1.

There are also indications that Ford may veto the entire foreign aid bill because of what he Presidential powers. Meanwhile Congress has adopted a \$4.4 billion foreign aid authorization bill which includes \$2.26 billion in economic and military assistance for Israel. The bill authorizes up to 25 percent of the amount approved for this year to be added on for the transitional quarter which would give Israel an additional \$550 million. The aid bill was approved by a 215-185 vote in the House and 51-35 in the Senate. Both bodies still have to vote on a bill appropriating the funds.

Ford, while campaigning in Dallas for the Ford, while campaigning in Dallas for the Texas Republican primary, told the Texas Jewish Post that he still opposed providing Israel with the \$550 million in transitional quarter aid. He said thate is "no need in a 25-month period for any more" after Israel has received \$4 billion during that time. The President was apparently referring to the \$2.2 billion he has apparently referring to the \$2.2 billion he nas asked Congress to provide Israel in the current fiscal year and the \$1.8 billion he is proposing for fiscal 1977. Earlier White House sources had also said that the President has not changed his mind over the transitional funding.

This came after Sen. Clifford Case (R, NJ) the ranking Republican on the Senate Foreign Relations Committee, said Ford was amenable to a compromise under which Israel would re-
