HERTZBERG SAYS BRUSSELS WAS A BUST

NEW YORK (WUP) -- Disturbed over the disunity in Jewish ranks on the issue of Soviet Jewry, Rabbi Arthur Hertzberg, President of the American Jewish Congress, has charged that the recent Brussel's Conference on the plight of the Jews in the USSR added up to a zero.

"Let's stop kidding ourselves," the noted rabbi stated at a press luncheon here last week, "we've not yet decided what to do."

Declaring that the situation in the world has changed radically since the Yom Kippur War of 1973, he called for a reappraisal of the total Jewish problem, including that of Israel. In the face of the present critical situation, he noted, "I do not believe time is on our side."

In an obvious reference of Mr. Ford's threat to veto a bill calling for additional financial aid to Israel, Rabbi Hertzberg said that during this election year "the President of the United States has turned obdurate."
