JEWISH LEADERS AT PENTAGON BRIEFING

WASHINGTON (WNS) -- An unprecedented top-level briefing was given by the Pentagon for more than a dozen national and communal Jewish leaders.

The approximately two-hour briefing, included remarks from Defense Secretary Donald Rumsfeld; Gen. George S. Brown, chairman of the Joint Chiefs of Staff; Gen. David Jones, Air Force chief of staff; Admiral James Holloway, Chief of Naval Operations, and Army Secretary Martin Hoffman. The Pentagon officials were said to have reflected the view that Israel cannot be militarily strong without a comparably strong United States defense. Brown was said to have indicated that while Israel is not regarded as a U.S. military ally, the U.S. may use Israeli territory for American military forces in the event other Mediterranean bases are closed to the U.S.

Several of those attending the briefing expressed appreciation to the Pentagon officials for the opportunity to exchange views on the military circumstances. Some of those who attended indicated that the briefing may have been held to obtain Jewish support for the needs of the defense establishment or because of the Presidential primaries or both.

Among those attending were Frank Lautenberg, Lawrence Peirez and Rose

Matzkin, of New York; Judge Paul Ribner; Leonard Goldfine and Ronald Rubin, of Philadelphia; Melvin Dubinsky, of St. Louis; Marvin Stone and Don Lowtiz, of Chicago, and Marilyn Branfman and Hyman Bookbinder, of Washington.

U.S. JEWS' CRITICISM MAJOR ISRAELI CONCERN

NEW YORK (WNS) -- American Jews who criticize Israel's policies cause more concern to Israelis than the Arabs or differences with the United States, former Premier Golda Meir told the Conference of Presidents of Major American Jewish Organizations.

Mrs. Meir said while she believed there should be frank and free discussions between American Jews and Israelis this did not include publicly-voiced criticism of Israeli policies. Mrs. Meir asked Israel's critics to demonstrate any lack of sincere desire and effort by Israel to seek peace. She said that American Jews had nothing to be defensive about in terms of Israel's policies.

When one Presidents Conference member noted that the feud between Premier Yitzhak Rabin and Defense Minister Shimon Peres has caused confusion among American Jews, Mrs. Meir replied that while she doesn't say the feud "is good...it has nothing to do with our policy." She said the government's policy is clear--Israel will not relinquish its historic and religious ties to the West Bank, but will make territorial concessions in return for peace.

Mrs. Meir made the same statement about the West Bank later at a luncheon attended by 1000 community leaders of the United Jewish Appeal.
