# Inti-Boycott Laws Needed

Despite the continued opposition of the Ford Administration, the evidence continues to pile up that strong legislation is needed to prevent the compliance of American business firms with the Arab boycott against Israel. Voluntary mea-

sures have not worked,
Treasury Secretary William Simon, in a
recent appearance before the House International Relations Committee, opposed any new
legislation as a hindrance to Middle East peace efforts and against American interests in the United States and the Middle East. "It is our considered judgement that confrontational policies will not move to remove the boycott and could undermine the delicate search for peace in that troubled region of the world," Simon told the congressmen,

No one wants peace in the Mideast more than Israel and American Jews. But it is outrageous for an American governmental official to argue that peace will be blockedunless the United States abandons its opposition to discrimination and its principles of decency.

Jewish leaders have long argued that if American firms stand up to the Arabs the latter will

back down because they need the economic power and know - how that only the United States can give them. Jewish leaders and many congressmen are now also saying that American firms want to buck the boycott but they need strong laws to back them up.

Dr. Arthur F. Burns, chairman of the Federal Reserve Board, told a congressional sub-

committee, if diplomacy will not end Ameri-can compliance with the boycott then Congress has to pass the laws that will do it.

## Syria Bewilders PLO

UNITED NATIONS (WUP) -- Frantic and stalking the corridors as lost souls, the PLO Observers here at the UN -- hitherto the center of attraction in this house of hate and intrigue which had given legitimacy to their mur-derous chief Yasir Arafat -- now find themselves both confused and bewildered.

world, has put a new posture to the entire Middle East situation greatly diminishing the former 'glamorous' role played by Arafat's PLO whose true nature has been bared for the whole world to see.

Who would have believed as little as a month ago that Arafat's former trusted friend and chief mainstay, President Assad, would turn into his worst enemy and attack his Palestinian strong-holds throughout Lebanon? Yet this has happened and there's no telling at this time what lies ahead.

Fearing the worst -- a complete collapse of his movement -- Arafat sent SOS calls to Syria's arch - enemies, the Iraqis as also to the Libyans and to the Algerians in the hope receiving aid in rescuing what is left of his O units. To date, the Libyans and Alger-PLO units. ians have pledged to send him token forces, while the Iraqis have dispatched troops to the Syrian border.

Mirroring the gravity of the situation now facing the Arab terrorists in Lebanon, the PLO representatives here at the UN have been circulating daily press releases attacking the Da-mascus intervention. A sample of such a re-lease, issued by the PLO news agency WAFA, reveals how frantic and disturbed Arafat's ter-rorists have become. It reads:

"The Syrian ultimatum to the Resistance to leave its positions on the axis leading to the Ain-Toura region, the Syrian Army's disarmament of Lebanese nationalist militants and the Palestinian commandos, the storming and the occupation of the Resistance offices, and the ar-rest of numberous Lebanese and Palestinian militants -- all presumably come under the militants -- all presumably come unitants heading: 'protection of the Palestinian Resistance' which is claimed as a pretext for the invasion in deceitful Syrian communiques.

'The true description of all these measures, however, is the liquidation of the Resistance, not its protection, in preparation for the imposi-tion of the capitulationist U.S. imperialist settlement on our people and the Arab Nation.

"The reality of the Syrian plot has been exposed by repeated Zionist and U.S. official declarations, which bear out everything we have previously said. This situation has reached the point of an explosion which will be, in the words of Yitzhak Rabin, 'a new Black Septem-

Indeed, the situation has reached such a desperate point for the PLO that Arafat went to such lengths as to express his fears that Syria might well reenact the Jordanian 'Black September' expulsion of his murderous guerril-las. But he warned "that while we are working sincerely to prevent such an explosion, we are more concerned and determined than ever be-fore to confront all (Syrian) attempts to strike at the Revolution and the Lebanese nationalist Revolution with all the forces in our power.
The Palestinian Revolution, which faced the (Jordanian) September 1970 conspiracy," he added, "is far stronger and far more able than ever to defeat all such conspiracies."
