

JUDGE GUY SEEKS FULL BENCH TERM

...Announced Candidacy

District Judge Adeliar D. Guy Monday announced his candidacy for the Eighth Judicial District Court post, a position he has held since his 1975 appointment by Gov. Mike O'Callaghan.

Guy, 52, has served as judge of Juvenile Court since January. Last year 21,000 complaints went through the court.

In his capacity as Juvenile Court judge, which he describes as "the most challenging I have ever had," he handles

rulings on any crime committed by a juvenile and oversees foster homes and foster parents.

Prior to his appointment Judge Guy was the chief deputy district attorney.

In May, Guy was honored for his work on the bench.

He said the present juvenile detention facilities are "not only too small, they are generally inadequate for the case load."

BICENTENNIAL U.S.-ISRAELI BROCHURE

NEW YORK (WUP) -- Ernest E. Barbarash, the veteran Jewish publicist, has produced a unique 24-page brochure which focuses on the major factors underlying the spiritual bond between America and the State of Israel, based on the common heritage shared by the peoples of both countries.

Published by the America - Israel Friendship League on the occasion of the nation's Bicentennial, the work underscores the unbroken thread in the fabric of American history, rooted in the influence of the Old Testament upon the Founding Fathers and the spiritual Legacy they had handed down to the generations that followed.

Entitled "The Birth of Two Nations -- An Historical Account of a Nation Born and a People Reborn," the multi-colored brochure documents America's consistent

report of the special Committee on the Inalienable Rights of the Palestinian People. Israel did not recognize the Committee and refused to participate in its deliberations as did the United States and most West European countries.

The committee, which included 16 members that have no diplomatic ties with Israel, called for Israel's total withdrawal from the occupied territories by mid-1977, the return of Palestinians to the area.
