GEORGE HARMON FOR JUSTICE OF PEACE

George L. Harmon, a thirty year resident and former Nevada State Legislator, filed for the office of Justice of the Peace representing Las Vegas Township.

Harmon served during four sessions of the legislature including the legislature's only annual session in 1960. As a legislator Harmon was instrumental in the restructuring of the Nevada Gaming Act in 1959, led the way in getting the first appropriation for the university, and the appropriation for setting up the Clark County Convention Authority. Harmon also introduced and guided through the legislature the first bill to create classrooms for retarded children in Nevada.

"My legislative experience in the enactment of laws is extremely important," Harmon explain-

Senator Herr, a democrat, is seeking her third term in the Senate. Previously, she had represented Clark County in the Assembly for four consecutive terms.

She is running in District 3, an "at large" race in which four senators will be elected.

ed, "as that experience represents an invaluable asset when being involved with the application and interpretation of the law, which are functions of the JP courts," Harmon added.

A successful businessman, now retired, Harmon pointedly stated that he is not an attorney. "Less than one per cent of the JP's in the nation are lawyers," Harmon said, "and they have been doing a fine job in serving the needs of their respective communities."

Harmon promised to maintain two nightly small claims sessions each week, if elected, and will cooperate with the other JP's in the township to speed up the criminal and civil justice systems.

"I am financially independent," Harmon stated, "and not afraid of heavy work loads and long hours - just check the record," Harmon said.

A civic leader, always active in community affairs, Harmon is a member of the Las Vegas Elks Lodge #1468, Loyal Order of Moose, Nevada Constables Association, Nevada Heart Association, Nevada Lung Association. He served as two time commander of the Veterans of Foreign Wars Post 1753 and is also a member of the American Legion Post #8.

Harmon's wife, Thelma, formerly served as president of the Clark County PTA Council, and 1st vice president of the state PTA council.

The Harmons reside at 921 Lady Marlene, in Las Vegas.

Mrs. Herr listed her address as 1405 Vegas Drive and her age as "legal."

The veteran legislator, the first woman senator in the state of Nevada, serves as chairman of the Senate Transportation Committee. She also has served on the Labor Committee, Taxation Committee and Health Committee.

Senator Herr, a 28 - year resident of Clark County, has long been active in youth and welfare programs. Recently she received the Catholic Welfare "Humanitarian Award" for her help with the new Regina Hall facility.

She was involved in the creation of the Spring Mountain Youth Camp and co-introduced the bill that created the state mental health facility here in Clark County. She has worked for improved conditions at the state prison and state institutions.

"I cannot think of retiring at a time like this," she said, "when there are so many things left to be done, for Clark County and for the state."

Among those priority items she listed the increasing need for mental health facilities and care, improvement of welfare and medic-aid and "extended educational problems."

"I want to encourage more growth of UNLV and the Community College program, and I want to work for a law school and more graduate programs in Southern Nevada," she said.

"We need reforms in the welfare program," the senator said. "I don't see how anyone can turn off benefits to the sick or elderly at a time when they need our help."
