Dear Mr. Secretary-General:
An article in the New York Times of June 23, 1976, directed my attention to the case of Solomon Alber, a Soviet citizen who applied in March, 1975, for permission to emigrate to Israel.

According to the article, which has since been confirmed by independent sources, Mr. Alber was demoted from his position as director of a computer research laboratory after he applied for the visa. His wife also lost her job as a pathologist. One of his children was beaten by schoolmates and taunted as a Jew.

I respectfully request that you investigate the matter and expedite permission for Mr. Alber and his family to emigrate to Israel, According to Article 13, Section 2 of the Universal Declaration of Human Rights, to which the Soviet Union is a signatory, "everyone has the right to leave any country, including his own..." his own

Mr. Secretary - General, I strongly sup-port the improvement of relations between our two countries, but I am afraid that incidents of this kind can only create obstacles to continued friendship between the United States and the Soviet Union.

Please be assured that I will continue to follow Mr. Alber's case with great interest. I would appreciate a response to this letter.
