## CHARLES ROMANELLI FOR ASSEMBLY 10

Charles Romanelli, retired letter carrier, resident of Las Vegas since 1962, secretary and liquor licensee of Italian-American Club, has filed for Assembly District 10.

Nick Kelly, former maitre d' at the Sands and Frontier, and popular past president of Italian-American Club is treasurer of Romanelli's campaign, and coordinator is Fran Kyle of Daughters of Erin.

Romanelli said he favors the elimination of state taxes on food, and will support legislation to double the appropriation for the Nevada Consumer Bureau. "At present there is no law that protects the tenant from being evicted for just cause. I favor some type of rental control and protection for tenants from eviction without cause with the exception of non-payment of rent, acute sickness exempted," Romanelli said.

Romanelli was honored recently in New York City with a gold membership card for his 57-year membership of the AFL-CIO. He was chaplain of the Culinary Union Local 226 for six years, and a char-

ter member of the By-Law Committee of Seniors in Action Inc. of Nevada.

He said he favors the elimination of boondoggling programs such as studying belly dancing, sex life of ants, measuring the aroma of elephants, and employing seniors during Christmas to examine toys.

He said he wants to meet with his opponents to debate abortion, pollution, women's rights and other issues.
