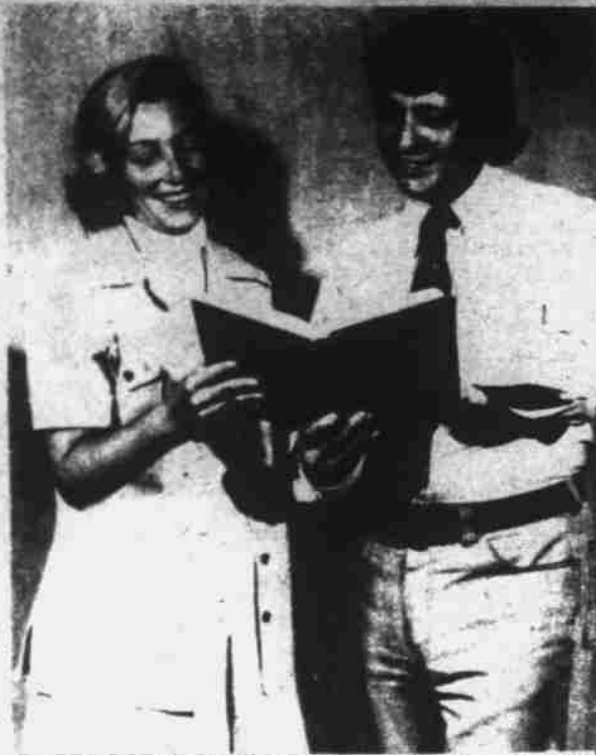


REFORM TEMPLE HEBREW SCHOOL CLASSES

Rabbi Stephen E. Weisberg and Mrs. Roz Sbarra, principal, announce the opening of Congregation Ner Tamid's religious and Hebrew schools for the forthcoming academic year. Religious school, which holds its classes on Sabbath/Saturday morning, will begin on September 11, from 9:30 a.m. to 12 noon. Hebrew School will begin on Tuesday afternoon, September 14, from 4 to 6 p.m. Rabbi Weisberg prepares all Bar and Bat Mitzvah students. According to Rabbi Stephen E. Weisberg, "With Roah Ha-Shanah, the Jewish New Year, coming relatively late, this year (Friday night, Sept. 24, and Saturday morning, Sept. 25), we thought it best to

begin our Religious and Hebrew School classes immediately after Labor Day and the opening of Public School."

There has been no increase in tuition for the congregation Ner Tamid religious and Hebrew schools, and parents are urged to enroll their children during the remaining weeks prior to the first day of classes, Saturday morning, Sept. 11. Tuition is \$35 per student, for the entire year. Congregation Ner Tamid, the new Synagogue of Las Vegas, is beginning its 3rd year of service to the Jewish community. TAY-SACHS SCREENING AT BETH SHOLOM

A Jewish community effort has been launched that will culminate on Oct. 24, Sunday afternoon, from 10:30 a.m. to 6 p.m., with additional hours scheduled as necessary. A voluntary \$6 donation is requested for the testing, but no one will be turned away for lack of funds. Tay-Sachs disease is an extremely rare, inherited illness which afflicts predominantly Jewish children of central and eastern European ancestry. Approximately 50 afflicted children are born each year in the United States, 10 to 15 in the southern California area. Tay-Sachs disease is always fatal, but can be prevented through a screening and testing program.
