The candidate supports mandatory sentences violent crimes, stating the present laws leave too much discretion in sentencing.

McMillan will support the Equal Rights Amendment when it comes to a vote, and will also vote for the elimination of sales tax on medicines and groceries.

"People should not be taxed on what keeps them alive. The tax puts a strain on low income families and elderly State of Nevada Division of citizens who can least afford it," she said.

In 1958 McMillan challenged Howard Cannon for a Senate seat. In 1960 he ran against Harley Harmon for a county commission seat and in 1972 he ran in the county commission race against James Brennan.

McMillan does not favor the Nevada Supreme Court decision forcing the commission candidates to run at large this year instead of from districts.

Consolidation would eliminate much of the 'power base" built up by long standing politicians in the community, said Mc-Millan.
