## HANK GREENSPUN, IN DESPERATION AT TRIAL, LIES ABOUT ISRAELITE

### ISRAEL WANTS ARAB ARMS LIMITATION

UNITED NATIONS (WNS) -- Israel is ready "now, even before peace is made" to negotiate with the Arabs on agreement to limit the flow of arms into the Middle East, Israeli Foreign Minister Yigal Allon told the 31st General Assembly.

But as long as the Arabs continue to arm themselves with highly - sophisticated modern weapons, "Israel is compelled to keep up and will keep up," he stressed. Allon also said that Israel is ready to participate in a reconvened Geneva peace conference but only with the original parties invited to Geneva in December, 1973. Allon said that at a reconvened Geneva conference, Israel would hope to negotiate "with each of our neighbors, a peace which will emerge from the region itself, a final peace settlement based on a fair compromise and which, on the one hand will provide Israel with defensible borders and on the other satisfy genuine Arab interests including, within the context of the settlement with our eastern neighbor (Jordan) a just and constructive solution to the problem of Palestinian Arab identity."

Allon stressed that "Peace is the foremost objective of Israel and its government will not be deflected from the constructive effort required to attain it." But, he emphasized, "Only a peace which serves the interests of Israel and its neighbors will endure." On the issue of terrorism, Allon said the record of the UN in combatting the international problem is "dismal." He welcomed the proposal by West Germany to the Assembly for a convention barring the taking of hostages and providing for the prosecution or extradition of terrorists.

Allon criticized the United Nations for what he termed "the power of a mechanical majority to bend the organization to its own purpose."

### PROUD ZIONIST A Disgrace to Jews

The LAS VEGAS ISRAELITE is subsidized by no one. If it were would we be fighting the bank practically every day to meet outstanding checks to stay alive? The ISRAELITE is in sole control of distribution and no one else is permitted to send the paper out to readers and regular subscribers.

Long before Hughes came to town, a Strip hotel agreed to pay the cost of addressing the cards if we would send the paper to Jewish leaders all over the world. The host hotel's name was carried in six point type. The only condition involved was that the hotel run an ad on a regular schedule to offset the postal expenses. Years later, when management at the hotel changed, we shuffled around for another hotel. It was an excellent method of publicizing Las Vegas as a resort area.

Several hotels were interested but the Hughes hotels beat them to it. Again the only condition involved was a regular schedule of ads to offset the cost and to satisfy the Post Office require-
