## 14 NEW SETTLEMENTS IN ISRAEL

JERUSALEM (WNS) -- Preparations have begun for the establishment of 14 new settlements in Israel and the administered territories, Moshe Rivlin, director general of the Jewish Agency, told a press conference.

He said the new projects were a direct

result of the world conference on Jewish solidarity held here. The 14 new settlements are the first phase of a larger 30-settlement program, Rivlin said. He said four settlements will be on the Golan Heights, one in the Jordan Valley, one in the Gilboa region, one in the Rafah salient near Gaza and the rest in Galilee. Six of the settlements will be for new immigrants.

Premier Yitzhak Rabin, meanwhile, has declared that the government's priorities for new settlements are those that will be established along the borders rather than "50 kilometers from Tel Aviv." Rabin also stressed the distinction between those settlements authorized by the government and those set up illegally by a group of zealots in open defiance of government policy, an obvious reference to the group of squatters of the Gush Emunim movement who have established an illegal encampment at Sebastia.

To the registered voters among our readers who may have not, as yet, made a final determination for some of the local candidates in next Tuesday's election, we offer personal reflections on a favored few. Here, in alphabetical order, are outstanding office-seekers, who deserve your consideration:

### BRYN ARMSTRONG COMMISSION F

We have known Bryn Armstrong since the day, 13 years ago, when he came down from Reno to take over as Managing Editor of the Las Vegas Sun. We had no intention of commenting about this contest until we were confronted with obvious and intentional misrepresentations about Bryn's character and reputation.

At the outset, we state firmly and without qualification that Sun Publisher Hank Greenspun will NEVER control any decision made by Armstrong as a County Commissioner. Anyone who feeds this rot to an unsuspecting electorate is not telling the truth.

Armstrong is an honest, fearless and impartial civic leader, who has gained the reputation as one of the most reputable newspapermen in the Southwest. The likes of Greenspun could not, under any circumstances, turn or sway the sterling attribute of decency possessed by Bryn.

The first inkling of any tampering by Hank, (who may very well try) we assure every citizen of Clark County, will mean immediate resignation from the paper by Armstrong. We know. We asked him point blank and he convinced us beyond any doubt.

## About Ballot Questions

A fundamental process of American Democratic system of government is the separation of powers into Executive, Legislative and Judicial.

We have this separation in Nevada, but the Judicial branch is sorely lacking in unified structure. There is a crying need for substantial improvements in our court system. A long view of these improvements would be a decided deterrent to crime through swifter, more effective justice. Public respect for our courts is a primary requisite to bring back law and order in Nevada.

That is why we beseech, we plead, we implore the voters on Tuesday to give every consideration to many of the questions appearing on the ballot. Most voters will probably be seeing them for the first time in the voting booth. It would be a calamity if the voters, through ignorance, were to forsake the opportunity to unify our courts.

We're talking about Questions four to nine dealing with judicial reform. Having passed the 1973 and 1975 legislative sessions they are now before the voters as Constitutional Amendments. Here is what they offer.

Question 4 will allow the legislature to pass laws permitting the justice and municipal courts to suspend sentences and grant probation.

This means that judges who would otherwise dismiss first offenders because of lack of jail space, would be able to maintain supervision if probation is violated.

PLEASE VOTE YES.

Question 5 establishes a permanent commission to recommend nominees to the Governor for each judicial vacancy.

This will take our court out of the hands of political leaders and insure the most qualified the opportunity to determine our fate in court.

PLEASE VOTE YES.

Question 6 creates a single state court system with the Chief Justice of the Supreme Court as Administrative head. District judges could be re-assigned to relieve a heavy court calendar and for specialized functions.

This could be a boon to over-worked Clark County District Court, and although some district judges may fear this amendment would infringe on their rights, we believe it would be beneficial in the long run.

Question 7 will allow the legislature to in-
