

# NATIONS OLDEST CEMETARY RESTORED IN PHILLY DEPT. OF COMMERCE

WASH. (WNS) -- The Sephardic Congregation Mikveh Israel in Philadelphia, the second oldest Jewish religious congregation in the United States, has received a letter from President Ford in connection with the congregation's dedication of a new synagogue.

The congregation along with the Touro Synagogue in Newport, R.I., received a letter from George Washington.

"In the year of our bicentennial, the dedication of your new synagogue carries special meaning," Ford said in the letter delivered by David Lissy, associate director of the President's Domestic Council whose late father was an officer of the congregation. "It marks the continuity of life and tradition of your congregation. It also reflects the tradition of George Washington and our other founding fathers that in a free land each should be free to worship as he chooses."

Mikveh Israel, which has had several buildings since its founding in 1740, is now located near its original building site.

## LIST CAUSES CONFUSION

The confusion precipitated by the Department of Commerce press release about the 59 companies in alleged compliance with the Arab boycott indicates once again the need for a law making compliance illegal, said Mr. Arnold Forster, General Counsel of the Anti-Defamation League of B'nai B'rith, at a meeting of ADL's Society of Fellows in Encino October 19th.

"Part of the confusion is the responsibility of the department itself by publishing names in the form it did," continued Mr. Forster. "Without the specifics, this was unfair to the companies identified, because the Department failed to release sufficient information to establish the facts clearly."

"In the Commerce Department report it is indicated that in no case did a company say it refused to comply. This, then, is another reason why an anti-boycott law is needed," continued Mr. Forster.
