Boleslavs Maikovskis, 75, of Mineols, Long Island: Kartis Destiavs, 65, of Baltimore, and Bronius Kaminskas, 73, of Hartford, are all charged with the murders of Jews and non-Jews in Larvia and Lithiania. Phoney Arab Peace

UNITED NATIONS (WUP) -- All this talk of a so-called Arab "peace offensive" as linked UNITED NATIONS (WUP) to unconfirmed reports that the PLO has softened its position vis-a-vis Israel does not tally in any way with the vicious attacks which are being waged here against the Jewish State almost daily in a number of UN organs.

First of all, Carter said the PLO, which is an alliance of guer illa organizations, is unrepresentative of the Palestinian problem and should not participate in any negotiations. He continued: "The PLO should not participate in any resumed Geneva peace conference because the PLO's stated aims are diametrically opposed to a peace which envisions the continued existence of Israel."

(It should be noted: The resolution against Israel, which was supported by the U.S., was initiated at a Committee on the Exercise of the Inalienable Rights of the Palestine People. This committee was established by the PLO and although the PLO was not a member, the terror group participated and controlled every stage of

the deliberations.)

Carter also stated: "While there must also be a humane settlement of the Palestinian situation, the Arabs and the world must understand that the Israelis did not cause the Palestinian problem." Carter went on, "Any territories ceded to the Palestinians should be part of Jordan and be administered by Jordan,'

Here's a final note on Ford's doublecross of his promises to Israel and American Jews,

On November 12, the U.S. at the U.N. sup-ported a Security Council resolution condem-ning Israel for alleged "repressiveness" in supervision of the administered territories and East Jerusalem,
