

WJC TO MEET RUSSIAN JEWISH LEADERS

GENEVA (WNS) -- The governing board of the World Jewish Congress on November 16, authorized WJC president Nahum Goldmann to meet with representatives of the Moscow Jewish community some time soon to discuss the possibility of Soviet Jewish relations with the WJC.

The board, some of whose members had qualms, acted on the request of Chief Rabbi Moses Rosen of Rumania who said leaders of the Jewish communities in the Soviet Union and Poland wanted information about the possibility of relations. Rosen told the board that maintaining the Judaism of Soviet Jews is a primary consideration because even if

100,000 Jews immigrated every year there would still be 3.5 million Jews in the USSR in 10 years.

Several board members feared that the fight for Soviet Jewish emigration might be weakened if the WJC met with the officials of the Moscow Jewish community. Rosen noted that the close relations of Rumanian Jewry with world Jewry has helped it secure a legal emigration policy. Earlier, the WJC decided to organize a world conference on Ladino "to celebrate and honor the Sephardic heritage" of the Jewish people.

The governing board's cultural commission also approved plans for the publication of a uniform series of Jewish classics in English, Hebrew, French and Spanish.

QUEBEC JEWS UNEASY ABOUT SEPARTISTS

MONIREAL (WNS) -- The some 120,000 Jews in Quebec were reported uneasy following the provincial election November 15 which swept the separatist Parti Quebecois into power.

They are concerned by the economic consequences and fear that if Quebec separated from the rest of Canada it would follow the pattern of radical nationalism and intolerance common to many newly-emergent states. Quebec Jews -- all but 5000 of whom live in Montreal -- voted overwhelmingly for Premier Robert Bourassa's Liberal Party.
