U.S., ISRAEL DENOUNCE UN REPORT SAID TO BE SUICIDE FOR ISRAEL

UNITED NATIONS (WNS) -- The report by the Committee on the Exercise of the Inalienable Rights of the Palestinian People which calls for Israel to evacuate all occupied territory by June 1, 1977 was approved by the General Assembly November 24 by a 90 - 16 vote with 30 abstentions.

In an address before the vote, Israeli Ambassador Chaim Herzog denounced the 20-member committee's report as being inspired by the PLO and said the UN cannot impose the report's recommendations on Israel. "We reject out of hand this report which serves only to move the area away from peace," Herzog said. He said the UN has been in "the forefront of those elements who would sabotage every effort in the Middle East toward peace." Stressing that Israel believes a solution can be reached on the basis on Security Council Resolutions 242 and 338, Herzog declared: "We will not be dictated to. We will not agree to any attempt to impose solutions. We have no intention of committing national suicide. We will not accept any alternative to the concept of the process of negotiations."

The report by the 20 - member committee also recommends allowing Palestinian refugees to return to their former homes or to be compensated for loss of property and urges the creation of a Palestinian State under the aegis of the Palestine Liberation Organization. The General Assembly resolution urged the Security Council

Investigate the Bums

Can you imagine anything more revolting, disgusting, shocking, offensive or nauseating than a large company preventing another business from bestowing a benefit on the public.

That's exactly what the monster insurance firms are doing in the matter of the 5.25 per cent rebate Sunrise Hospital has been tendering to patients who check in on a Friday or Saturday.

Blue Cross and Nevada Industrial Commission are among the insurers who are gobbling up the rebate intended for patients. As a result Sunrise Hospital is suspending the plan, which has been in effect since January, until the matter is settled in court.

Thus the stinking insurance companies will not gain a single penny and the public will be the loser. Whoever they are, the "brains" behind the actions of the individual insurance companies, should be named and singled out as a menace. The public should rise up against them in concerted protest to their damnable acts.

Sunrise Hospital's plan was proving a success. The rebate incentive made greater use of facilities on weekends, increasing operating efficiency and reduced costs. The savings were then passed on directly to the patient.

During the off - peak days of Friday and Saturday, patient admittance had increased 30 to 50 per cent. As a result Sunrise Hospital is one of the few medical operations in the Country that has not increased its prices since January.

Sunrise Hospital should be honored for its public - mindedness in introducing new cost-cutting effectiveness. Instead the insurance companies insist that if Sunrise wants to bestow a gift on its patients, the gift belongs to them, the vultures who prey on the unfortunates caught in their web.

It's like a landlord who refuses to paint a tenant's apartment and when the tenant paints on his own, the landlord raises the rent.

If enough of us band together and make enough noise, perhaps our elected officials will pass laws curtailing the actions of the insurance companies, who have no compassion for the little man. The insurance companies can't lose because as soon as claims against them rise, they raise the rates. That is why they accumulate billions in reserve funds for investment at the highest rates.

Us suckers insure ourselves through the
