

20TH ANNUAL LAW DAY ON MAY 1

In an effort to increase public understanding of the role of courts and the part the public plays in improving our judicial system, the twentieth annual LAW DAY, USA, on May 1st this year will stress the theme, "Partners in Justice," it was announced by U. S. Magistrate and State Law Day Chairman, Joe Ward.

Our courts need the support of all Americans, and they should be made aware of the major problems facing their courts today, Ward added.

In cooperation with local, state, and federal courts the law day committee will present meaningful programs illustrating the alliance of the public in the

goal of the courts to administer justice fairly and equitably.

LAW DAY, USA, is set aside on May first each year by resolution of Congress and Presidential proclamation as "a special day of celebration by the American people in appreciation of their liberties," and because the event falls on Sunday this year, church leaders of all faiths will be encouraged to conduct appropriate services in support of the role of law in establishing religious freedom.

JEW. WITH CEREBRAL

PALSY ORGANIZED

The formation of The Association of Jews with Cerebral Palsy has been announced. Its purpose is to unite Jews who suffer from cerebral palsy to deal with their common social, religious, medical, educational and vocational problems. Larry Finklestein, 32, a Philadelphian who himself has cerebral palsy, is the voluntary director.

It is estimated that 750,000 people in the United States have this handicap, suffered at birth,

which causes the victim to lack control of muscular movements. This means, says Finklestein, that about 18,750 Jews suffer from this disability in the United States alone. Figures also indicate that about 375 Jewish babies are born with cerebral palsy each year.

Finklestein notes that the disease has nothing to do with intelligence. The problem is that the victim's nearly uncontrollable twitching and other physical contortions, and the inability to pronounce words clearly, often leave this impression with the uninformed public. The result, he says, is that cerebral palsy victims find great difficulty in getting other than the most menial jobs and participating in ordinary society.

The Jewish community is being asked to submit the names of Jewish relatives and friends who have cerebral palsy, whether they live in the United States, Canada, Israel or elsewhere. Finklestein also requests the assistance of Jews who can type letters and answer inquiries
