The confirmation class was told about the Holocaust, whereupon one youngster said to the teacher, "You've told us the Jewish side. Now what about the German side?"

This is one episode in a gripping book put out by Bloch Publishing Co. in which a cluster of relatively young people tell us what it is like to remember the horrors of Hitlerism or to live with parents who went through that inferno.

Entitled "Living After the Holocaust," the book includes essays, poetry, dialogues, teaching techniques offered by the contributors, many of whom are on college faculties.

One of the offerings is by Hans Herda, who grew up in a Nazi home but converted to Judaism, probably out of a sense of guilt. Now living in Lexington, Mass. Herda warns that we must not yield to the desire of blacking out the memory of Nazism.

The book's two editors, Lucy Steinitz and David Szonyi, engage in a symposium with others who ponder the impact of the Nazi experience on their lives and the lives of their parents.

One brilliant Orthodox rabbinical scholar, Dr. Michael Wyschogrod, wrestles with the theology of the Holocaust. We must not blame God, says he.

DETROIT (WNS) -- Arab spokesmen warned here that if Congress adopts pending legislation to combat the Arab boycott of Israel American businessmen will lose billions of dollars in sales. The Saudi Arabian government plans to spend \$150 billion in economic development programs between

1975 and 1980 and we would like to see a good deal of the work done by American firms," Tarek Shawaf, head of the biggest engineering consulting firms, told some 200 Arab-Americans and local businessmen. SAN FRANCISCO (WNS) -- An irate group of about 50 Jews wrecked a newly-opened bookstore, featuring Nazi literature and a large swastika in its front window.

Later in the evening five stained glass windows were smashed in the Temple B'nai Emunah which was directly across the street from the Rudolf Hess Bookstore. The incident came as the owner of the building Nathan Green, an Auschwitz survivor was in the legal process to have the Nazi group evicted from

the store. Green said he did not know that the group was a Nazi one when he rented it for use as a bookstore.
