his news Feb. 8, conference Carter said "the sale concussion bombs to a foreign country is an item that concerns me very much." Carter sald he has the option of blocking the sale but has not made a decision

While Carterdid not mention Israel it was obvious he was referring to the sale of the bomb which was promised Israel last October by Ford. The Administration has been studying the sale of the bomb as well as M-60 tanks, 155-mm self - propelled howitzers and a night-vision system which Ford promised Israel last October, At his news con-

ference Carter stressed the Ford Admin-istration's "announcement that concusbombs would be sold was not cleared State Dewith the

partment nor the Defense Department, I've asked them to analyze the political and military consequences of the sales." The concussion bomb which causes widespread destruction over an area of several hundred feet, has never been sold abroad.


