

23 LISTS REGISTERED MAY 17 ELECTION

JERUSALEM (WNS) -- The campaign for the May 17 Knesset election is officially underway after 23 lists registered and paid their IL 40,000 deposits by the April 12 deadline.

The ruling Labor Alignment went into the campaign with their partnership intact after Mapam decided to remain in the Alignment but review its relationship with Labor after six months. The last minute crisis occurred because most Mapam members were opposed to Defense Minister Shimon Peres who was selected by Labor to head the Alignment after Premier Yitzhak Rabin stepped down as the party's leader following the announcement that his wife, Leah, would be prosecuted for the illegal account the Rabins had in a Washington bank. The Mapam leadership bureau was divided 8 - 8 and the central committee seemed to be divided evenly too during a daylong meeting April 11. But it decided to continue with Labor after veteran Mapam leader Yaacov Hazan proposed the resolution which would allow Mapam to re-examine the relationship.

The alignment list has Peres, Foreign Minister Yigal Allon and former Foreign Minister Abba Eban in the top three spots. Rabin remains on the list in the 20th spot, which should assure him of re-election.

Former Premier Golda Meir, who was expected to get the traditional place of honor for veteran party leaders -- 120, the last spot -- is not on the list. This was seen by some as a sign that Mrs. Meir was registering her disapproval of Peres as party leader.

Meir Talmi, Mapam's secretary was given the number five spot on the Alignment list and Naftali Feder, Mapam's political secretary, 10th place.

In addition to the Labor Alignment, Likud, Shlomzion, the NRP and Yadin's group, the other parties entered are: Independent Liberal Party; Aguda Israel; Poalei Aguda, running separately from Aguda this time; Citizens Rights Party, headed by Shulamit Aloni; Sheli, headed by Arye Eliav, Meir Peyil and Uri Avneri; Rakah - the Democratic Front for Peace and Equality, with the old pro-Moscow Rakah Communists plus Black Panthers, headed by Panther leader Shalom Cohen and former Ashdod port boss Yeshoshua Peretz; Arab Reform Movement; Zionist Panthers; the Movement for Economic and Social Renewal, headed by former Labor MK Mordechai Ben - Porat; Co-existence in Justice, an Arab list; Renana, Meir Kahane's Kach movement; the Women's Party; the New Generation of Israel; the United Arab list, a Labor affiliate; Beit Yisrael Party, a Yemenite list and a one - man list Samuel Flatto - Sharon, the financier and builder.

TO DECIDE ON SALE OF CONCUSSION BOMB

WASH. (WNS) -- President Carter is expected to make a decision soon on whether Israel will receive the concussion bombs promised it by the Ford Administration.

At his news conference Feb. 8, Carter said "the sale of concussion bombs to a foreign country is an item that concerns me very much." Carter said he has the option of blocking the sale but has not made a decision yet.

While Carter did not mention Israel it was obvious he was referring to the sale of the bomb which was promised Israel last October by Ford. The Administration has been studying the sale of the bomb as well as M-60 tanks, 155-mm self-propelled howitzers and a night-vision system which Ford promised Israel last October.

At his news conference Carter stressed the Ford Administration's "announcement that concussion bombs would be sold was not cleared with the State De-

partment nor the Defense Department. I've asked them to analyze the political and military consequences of the sales." The concussion bomb which causes widespread destruction over an area of several hundred feet, has never been sold abroad.
