

ZANTIGO MEXICAN-AMERICAN RESTAURANT OPENS FIRST UNIT IN SOUTHERN NEVADA

A new chain of nationally franchised specialty restaurants, Zantigo Mexican-American Restaurants, has commenced operations in Southern Nevada with the opening of its first unit at 2300 East Lake Mead Boulevard in North Las Vegas.

Torrey L. Slade, general manager of Zantigo Restaurants, said a second unit is under construction at 4650 Maryland Parkway near the UNLV campus and that other units are planned for the greater Las Vegas area.

The new restaurant chain is a subsidiary of Heublein, Inc., also the parent corporation of over 4,000 Kentucky Fried Chicken stores in the United States. Slade Enterprises, with corporate headquarters in Las Vegas, owns the franchise for the State of Nevada. The company recently opened two Zantigo Restaurants in Reno.

according to Slade. The menu features about 15 flavorful Mexican-American dishes, including tacos, burritos, enchiladas, chilitos and tostadas. The recipes were gathered from

throughout the South-west United States and Northern Mexico and are prepared to satisfy American tastes for mildly-spicy (not-too-hot) foods.

After two years of test marketing in the Midwest, Slade said KFC Corporation began franchising in March of 1976. Sales have increased over 40 per cent since the company put its extensive resources to work developing the current brand image, improving service, merchandising and advertising.
