Anticipating a crisis in energy, Bible authored and became known as the "father" of geothermal steam development legislation.

Bible was Storey County district attorney and Nevada attorney general before his election to the Senate in 1954.

He was named a Distinguished Professor of Political Science by the University of Nevada, Reno, where he lectures in advanced political science courses.
