CONSERVATIVE 2 YEAR MORATORIUM FOR FEMALE RABBIS

NEW YORK -- Jewish women who had hoped to become Conservative rabbinical students had their hopes dashed again when the movement's rabbis declared a two-year moratorium on discussion of female rabbis.

The action came at the recent annual conference of the Rabbinical Assembly, the professional association of Conservative rabbis, after considerable pressure had built up during the past few years over admitting women to the Jewish Theological Seminary, the Conservative rabbinical school. The

Rabbinical Assembly decided that a commission whose members will be picked by the Seminary's Chancellor -- known for his opposition to the ordination of women -- will deliberate the issue during the moratorium period.

The inside story behind the seminary's continuing refusal to consider admitting women rabbinical students was revealed in an exclusive investigative report by Amy Stone in "Lilith" magazine's third (spring-summer) issue.

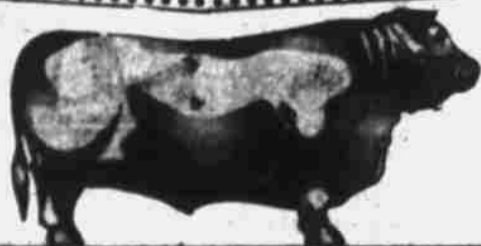

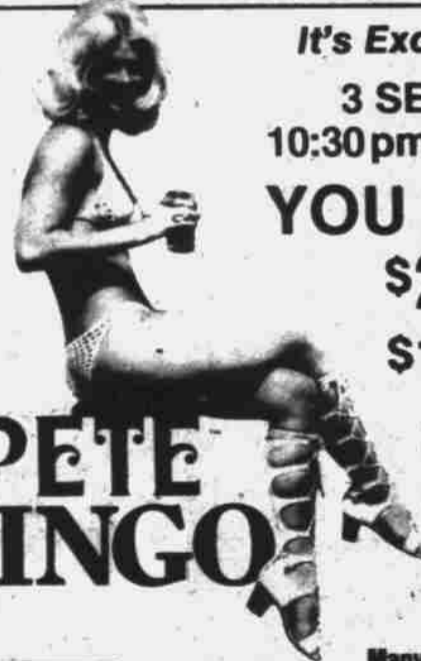
