DAYAN EXPLAINS TRUE MEANING OF 242

UNITED NATIONS (WUP) -- In his address before the General Assembly Foreign Minister Moshe Dayan confronted an over-crowded Hall minus the Arabs who had walked out and lectured the delegations on the true meaning of Resolution 242.

"Let us be quite clear what that Resolution does and does not say," he declared. "It does not require Israel to withdraw unilaterally from territories it occupied in 1967. It does not call upon Israel to leave all of those territories. It does not make peace negotiations contingent upon such withdrawal. It does not fix boundaries."

He then pointed out that "the wording of the Resolution makes it perfectly clear that new boundaries are to be determined between the States of the region. The statement that 'secure and recognized boundaries' must be negotiated," he emphasized, "implies that the previous boundaries are not secure and not recognized. The fact that new boundaries are to be reached can also be inferred from the fact that Arab and Soviet pressure for the inclusion of a reference to 'withdrawal from all the territories' was unsuccessful."

Thus, Dayan added, "we have to establish new boundaries, and not to return to the old ones. We have to negotiate permanent boundaries which will afford Israel's security."

In his full knowledge of the perverted interpretation Israel's enemies have given to the only UN document which serves as the basis for the reconvening of the Geneva Conference, Dayan continued with his clarification as follows: "According to Resolution 242, the peace settlement must include the 'termination of all claims of states of belligerency and respect for and acknowledgment of the sovereignty, territorial integrity and political independence of every state in the area.' The settlement is therefore to be reached between the States, and not to involve the participation of any organization whatsoever."

"Resolution 242 makes no mention whatsoever of the PLO. The PLO is a terrorist organization whose record is one of deliberate and indiscriminate atrocities against innocent civilians, including women and children."

"The PLO is governed by the Palestinian National Covenant of 1964, as amended in 1968, and reconfirmed as recently as March of this year by the Palestinian National Council in Cairo."

Article 6 of this Covenant calls for the expulsion of the vast majority of the Jewish population from our country. In Article 15, it calls for the elimination of Zionism. In Article 19, it calls in effect for the destruction of the State of Israel. In Article 20, it makes the preposterous assertion that 'claims of historical or religious ties of Jews with Palestine are incompatible with the facts of history.' In Article 21, it declares that "all solutions which are substitutes for the total liberation of Palestine' are rejected; that is, any plan which falls short of the destruction of Israel."

In referring to the new Israeli settlements, Mr. Dayan told the Assembly: "Under international law, neither Jordan nor any other Arab state has any sovereign territorial rights in the West Bank or in any other part of what was Mandatory - Palestine in 1948 when the United Kingdom surrendered the Mandate. No state

today had any claims of sovereignty to what was Mandatory Palestine that are better than, or even equal to, Israel's claims."

He then reminded the Assembly delegates about something they had apparently completely forgotten. "The Arab states," he said, "rejected the UN Partition resolution, and in violation of the UN Charter, they used force in an attempt to prevent its implementation. The Arab use of force in 1948 was an act of aggression, and not of self - defense. No rights accrued to them from that act, and they were in fact subject to the restrictions that international law imposes on a conquering and 'occupying' army..."

Terrorism Strikes UN

UNITED NATIONS (WUP) -- Terrorism has 'struck' this world organization.

At last the UN stands challenged to do something concrete about the hitherto sidetracked item on international terrorism and the taking of hostages. All past attempts to adopt appropriate resolutions have been aborted by the Arabs and their Third World supporters.

The spectacular results of the West German rescue operation at Mogadishu, Somalia, have suddenly brought to the fore here at the UN the fact that it was the Israelis who had led the way in facing up realistically to the horrors of terrorism, the holding of hostages and the killing of innocent pilots.

It can now be said that the German action has, in this overwhelmingly anti - Israeli House of vile rhetoric, revived some sympathy for the Israelis as a whole, and there can be no doubt that the global reaction to the Bonn commando undertaking -- resurrecting the Entebbe operation -- has in some measure diminished the support many delegations have been giving to the PLO terrorists here. Two of the Lufthansa hijackers were Arabs and the other two, Germans, who were heard speaking Arabic, had trained in PLO camps.

The cold - blooded murder of the Lufthansa pilot, and the resultant challenge by the International Federation of Air Lines Pilots Association demanding that the UN act expeditiously in coping with the problems of hijacking, has hit home here in this snail - pace organization the urgency of the situation -- so much so that a tense and overwrought Kurt Waldheim summoned correspondents to a hastily-convened press conference last week during which he announced that he is doing everything in his power to bring about quick UN action to prevent a threatened pilots strike.

Indeed, for the first time in the history of aviation, the Pilots' Associations have been

was depicted as a newspaper publisher who used his "power of the press" and a systematic kick-back procedure to secure millions of dollars of loans and other payments from the Hughes empire. (This is a far cry from a man dedicated to the prosperity of the Las Vegas business community. It is more like a con - man dedicated to the prosperity of Hank Greenspun.)

The judge goes on to tell about the \$500,000 advanced by Hughes to the Sun in 1967 for prepaid advertising. But the hotels continued to pay for the ads each month for four years until the half million advance was discovered after Robert Maheu was fired. (The LAS VEGAS ISRAELITE broke this story in 1971. Maheu directed Hughes operations in Nevada from 1966 to 1970.)

The judge said Greenspun testified that the purpose of the \$500,000 advance was to obtain good security, "to have the kind of hold on them that they have to use our paper."

The judge stated Mr. Maheu arranged for payments and loans on extremely favorable terms from Hughes Tool to Mr. Greenspun and the Sun totaling \$11,373,064.45 (Greenspun never offered advice to businessmen when he was grabbing all this loot. But he did loan Maheu \$150,000 the day after he pocketed a \$4,000,000 loan from Hughes. The loan, you might have guessed, was arranged through Maheu.)

Now here's what the judge had to say about comparative advertising in the R-J and the Sun, from a study that included independent marketing surveys, comparisons of advertising rates and consideration of the wishes of the stars appearing at the Hughes resorts: According to circulation and advertising cost figures of both newspapers the R-J was far and away a better medium buy for an advertiser, with a lower cost-per-thousand readers. The judge's decision in the court action goes on: According to undisputed expert testimony, a normal advertiser would be justified from a business standpoint in advertising in only the less expensive of the two daily newspapers. The plaintiff's (Greenspun's) records indicated that over 200 businesses in Las Vegas had reached the same conclusion and

What he stated then takes on a special meaning at this time and is fully applicable to the present situation confronting the United Nations.

His words have come to life again!

"I stand here as an accuser against the forces of evil which have unleashed a wave of piracy and terrorism threatening the very foundation of human society. I stand here as an accuser of the countries that, because of evil design or lack of moral backbone, have collaborated with these bloodthirsty terrorists. I stand here as the accuser of all those in authority throughout the world who for cynical expediency have collaborated with terrorism.

"I stand here as an accuser of this world organization, the United Nations, which has been unable, because of the machinations of the Arab representatives and their supporters, to coordinate effective measures in order to combat the evil of world terrorism.

"I stand here as the accuser of those dele-
