

# NAZI WAR CRIMINALS UNEARTHED

UNITED NATIONS (WUP) -- Intelligence agencies -- headed by the CIA, FBI and Defense Department -- have secretly utilized as many as 149 alleged Nazi criminals, accused of collective responsibility for the genocide of some 2.4 million people, mostly Jews, during World War II, it was disclosed here this past week by colleague Charles R. Allen, Jr., noted authority on the question of Nazi war criminals residing in the United States.

During a visit with your correspondent at the WUP Bureau here, Mr. Allen reported in an exclusive interview on the extensive testimony he had given on July 19 before the Judiciary Committee's Subcommittee on Immigration headed by Joshua Eilburg (D. Pa.) in the Rayburn House Office Building. He said that he had presented before the Committee extensive documentation and analyses of his studies of U.S. Government utilization of alleged Nazi War criminals and collaborators for more than three decades.

Mr. Allen revealed that in his testimony he had detailed representative selections of the use of individual accused Nazi war criminals by various U.S. Government Agencies. He noted that his particular focus was on the State Department, CIA, FBI, Defense Intelligence, Army and Air Force Intelligence and NSA (National Security Agency). In all, he had listed 13 Government Agencies which he claimed had some involvement with Nazi war criminals and collaborators.

He said that his testimony before the Eilburg Committee had coincided with massive detailed requests he had made of the 13 Government Agencies under the FOIA (Freedom of Information Act) and the Privacy Act. He had also considered what he termed "transplanted" Nazi organizations from the World War II period which, he claimed, had served as vehicles and conduits for Nazi war criminals.

"These groupings," Allen said he had told the Committee, "have served as veritable escape mechanisms for genocidists who, in turn, have interacted with our own native extreme Rightists, thus befooling our own body politics with their patent fascism."

Allen noted that he had further testified about specific bureaucratic officials in various Government Agencies who have "in one way or another provided protection for many of the Nazi war criminals who had found haven in the U.S. since 1945."

During his lengthy testimony in Washington, Allen told this writer, he had submitted additional data about Government failure to examine possible linkages between American citizens who were dues-paying members of the German Nazi Party of Hitler's Third Reich and those Nazi war criminals who came to the U.S. after World War II.

On several occasions, the dynamic author Allen said he had testified, American Intelligence Agencies had attempted, in his words, "to harass, obstruct and intimidate my investigatory and research efforts on this subject" of Nazi Genocidists in the U.S. and their utilization by the Government. He informed the Committee that he is ready to provide it with what he calls "precisely concrete documentation," which will constitute the bases of suits he plans to file against these Agencies.

Allen said that he had also commented on the recent Government Accounting Office (GAO) report of May 15, 1978, which found "no evidence of a widespread conspiracy to obstruct probes of alleged Nazi war criminals by Agencies of Government."

The Eilburg Committee has expressed "dissatisfaction" with the GOA report, Allen declared.

Back in 1963, Charles R. Allen, Jr. authored a series of articles, later issued as "Nazi War Criminals Among Us" which offered evidence for the presence of some 15 hard-core Nazi war criminals living in the United States. Within a year or so, he revealed 42 more accused of war crimes during World War II.

Colleague Allen, in close touch with this writer on the exposure of several alleged Nazis, is currently completing a new book on Nazi war criminals in the United States which, he says, "is an in-depth history, analysis and documentation of the reasons why our Government and, even more importantly, we ourselves bear a terrible responsibility for not resolving what is, above all, a deeply moral issue."

## TERRORISM, NEAREST RELATIONS STRESSED

WASH. (WNS) -- The United States must take into account terrorism, the "support around the world for Palestinian nationalism" and Israel's position on the "world scene" when considering the Arab-Israeli conflict, Harold H. Saunders, Acting Assistant Secretary of State for Near East and South Asian Affairs, stressed.

Addressing 1,000 at the first national Young Leadership

Council of the United Jewish Appeal, Saunders indicated priority for five other factors. He said they are the possibility of an "accidental confrontation" between the U.S. and the Soviet Union in the Mideast; the fact that the U.S. gets 20 percent of its oil supply from the area; the oil revenues and capital holdings in the region which can have a "sharp impact" on the "global economic order;" the fact that

Saudi Arabia and Algeria are "organizers of the poorer nations" and the possibility that a Mideast conflict could result in another oil embargo.

Saunders, who had been director of the State Department's Intelligence and Research Division for two years, said that in the 1970s

the Mideast has become more vital to the U.S. than it was before because of U.S. and European oil requirements and the needs of Israel. He said an Arab-Israeli peace is "crucial" in the "hard calculus" of American interests in the area.
