JERUSALEM (WNS) -- Israel went on a security alert to prevent reprisals after five Palestinian terrorists, including the mastermind of the 1972 Munich Olympic massacre, were killed when a bomb exploded in their car in Beirut.

UNITED NATIONS (WNS) -- The Security Council warned Israel not to obstruct the activities of the United Nations Interim Force in Lebanon as it extended the mandate of the 6000man international force for another five months.

WASHINGTON (WNS) -- The United States will not deal with the Palestine Liberation Organization until the PLO accepts Israel's sovereignty and right to exist in peace, President Carter stressed.

NEW YORK (WNS) -- Two Geneva banks, both subsidiaries of American corporations, have withdrawn from a syndicate organizing a \$33 million loan to Algeria after the Bank Rothschild of Zurich was excluded because of its Jewish ownership.

WASHINGTON (WNS) -- Former Secretary of Treasury John Connally cited the strategic importance of Israel during a press conference in which he announced his candidacy for the Republican presidential nomination in 1980. "I have long looked on Israel not only as a nation that deserves our support on a normal standpoint, but I have long looked on Israel as a nation that deserves our support from a strategic standpoint," he said.

SAN FRANCISCO (WNS) -- The chief spokesman for a delegation of visiting Libyans, who are in the United States at the invitation of President Carter's brother, Billy, quoted the "Protocols of Zion" at a press conference here, Ahmed Al - Shahati, head of the Foreign Liaison of Libya's Congress, said Zionism was "racist" and tries to give privileges to just a few.


TEL AVIV (WNS) -- After a 17 - hour flight from Manila 102 Vietnamese refugees arrived in Israel Jan. 24.
