

### CHICAGO NAZI STRIPPED OF CITIZENSHIP

CHICAGO (WNS) -- Frank Walrus, a 55-year-old German-born Chicago resident had his U.S. citizenship stripped May 30 by a federal judge after being found guilty of concealing his part-

icipation in Nazi war crimes when he applied for the citizenship. His attorney said that Walrus would appeal the ruling by Judge Julius Hoffman senior U.S. district court judge in Chicago. A spokes-

man for the Immigration and Naturalization Service said that the INS would begin deportation proceedings against Walrus who first arrived in the U.S. in 1959 from Poland as a Polish citizen.

Walrus was accused of the murder of some two dozen Jews, including young children, in Poland from 1939 - 43 and of being "particularly active in the merciless beating and mistreatment" of Jews in the Polish cities of Czestochowa and Kielce.

### CHARLOTTE JACOBSON CHARGES RUSSIAN TACTICS

NEW YORK (WNS) -- The Soviet Union is using procedural abuses to block the emigration of Soviet Jews it was charged here by Charlotte Jacobson, chairwoman of the National Conference of Soviet Jewry's Research Bureau.

She said the publicity about the increases in the number of Jews emigrating was diverting attention from this. "The true measure of oppression in the Soviet Union is the number of Jews trying to get out, not the number who make it," Mrs.

Jacobson declared. "To the best of our knowledge, there are now over 180,000 active letters of invitation sent to Soviet Jews and that number is growing every day. Viewed this way, we see that, if anything, the situation will be getting worse."

Mrs. Jacobson said she has received information which indicates officials are changing the ap-

plication procedure "to both discourage applicants and to artificially reduce their number." The Research Bureau estimated that about 28,000 Jews left the USSR by the end of 1978, the highest num-

ber since 35,000 left in 1973.
