

JEWISH NEWS BRIEFS

TEL AVIV (WNS) -- A new political party to fight against any territorial concessions is being formed by Prof. Yuval Ne'eman, former president of Tel Aviv University.

LONDON (WNS) -- Foreign Office officials blocked a plan approved by both Prime Minister Winston Churchill and his wartime Foreign Secretary, Anthony Eden, to bomb the Auschwitz concentration camp in 1944.

WASHINGTON (WNS) -- An amendment cutting by 25 percent the United States contribution to two United Nations units which disseminate Palestine Liberation Organization propaganda was approved by the House Foreign Affairs Committee.

TEL AVIV (WNS) -- It now takes more than 20 Israeli Pounds to equal a U.S. dollar following a 2.8 percent devaluation. The Pound is expected to drop in value further because of the new monetary system going into effect in Western Europe.

LONDON (WNS) -- The exclusion of Bank Rothschild of Zurich from an international \$33 million loan for Algeria earlier this year was not due to pressure from the Algerians but from Jordanian and Kuwaiti members of the loan syndicate.

NEW YORK (WNS) -- Boris Kalendarov, a 21-year-old Leningrad refusenik and unofficial Hebrew teacher, was arrested for "draft evasion."

JERUSALEM (WNS) -- Mrs. Rosalynn Carter, who accompanied President Carter on his Middle East journey, planted a cypress sapling on the outskirts of Jerusalem.

JERUSALEM (WNS) -- Premier Menachem Begin was confined to his home with a cold. He got the chill standing in sharp wind and without an overcoat outside the King David Hotel during President Carter's visit.

ROME (WNS) -- The military court of La Spezia has rejected an appeal for freedom by Walter Reder, a former Austrian SS commander, serving a life sentence for the mass murder of 1,834 people, mostly women and children, in the northern Italy town of Marzabotto during World War II.

NEW YORK CITY -- Former Supreme Court Justice Moshe Etzioni, a member of the ORT-Israel and World ORT Union Executive Committees, has been named chairman of an Israeli Government special committee established to investigate the status and working conditions of the country's teachers.

LOS ANGELES -- The Anti-Defamation League of B'nai B'rith will conduct its Second Annual Holocaust Workshop for Teachers on Thursday, April 5, 1979 from 4:00 p.m. until 9:00 p.m., at the Jewish Community Building, 6505 Wilshire Boulevard, in Los Angeles.

NEW YORK CITY -- The American Jewish Congress has hailed the Baltimore City Council for enacting a law to bar contractors who participate in the Arab boycott from doing business with the city.

NEW YORK CITY -- Shirley Leviton of Hewlett Harbor, New York, has been elected President of the National Council of Jewish Women.

NEW YORK -- Pope John Paul II, after an audience last Monday with a group of Jewish leaders from around the world, expressed the wish "to come to Israel soon."

NEW YORK -- Edwin Shapiro, of New York City and Rock Hill, New York, has been elected President of HIAS, the worldwide Jewish migration agency.

WEST POINT -- The reading of the Hagaddah, the asking of the "Four Questions," the singing of Passover songs, will take place at the United States Military Academy at West Point, N.Y., when Jewish cadets, personnel, officers and their families hold a "Community Seder" in April at the Academy.
