KNESSET REJECTS SINAI WITHDRAWAI

JERUSALEM (WNS)

-- The plan agreed to in Washington by Israeli, Egyptian and American officials for monitoring Israel's withdrawal from the Sinai was unanimously rejected by the Knesset Foreign Affairs and Security Committee. The com-

mittee designated its chairman, Moshe Arens of Likud, and Yehuda Ben Meir of the National Religious Party to meet with Premier Menachem Begin for clarification and possible changes.

The committee acted after it was briefed by Foreign Minister Moshe Dayan who, along with Defense Minister Ezer Wiezman, hammered out the arrangement in a series of meetings with Secretary Vance State Cyrus and Egyptian Defense Minister Kamal Hassan Ali.

plan calls The for joint Israel and Egyptian patrols in the Sinai buffer zones; United States aerial reconnaissance; extension of the duties of the 200 American civilians who have been monitoring electronic early warning systems at the Sinai passes since the end of the Yom Kippur War to include all of the Sinai, and the con-tinuation of the present limited function for the United Nations Truce Supervisory Organization (UNTSO) in the area. Plight of Soviet Jours

NEW YORK -- Burton S. Levinson, Chairman of the National Conference on Soviet Jewry (NCSJ), issued this New Year message:

"Soviet Jews today are a people who face a bitter irony -- they are not permitted to be Jews, nor are they permitted to stop being Jews.

"Despite ongoing harassment by Soviet authorities, a blatant anti - Semitic campaign in the
Soviet media and trials against those attempting
to exercise their basic human rights, Soviet Jews
have displayed imaginative and ongoing courage...a courage we must match with our solidarity.

"The last decade has witnessed a historic exodus of Soviet Jews. Since 1967, more than 200,000 have left the USSR to rejoin their families in Israel and elsewhere. But their departure represents only the tip of the iceberg, for thousands more daily petition Soviet authorities for their right to leave the USSR, with all cultural and religious rights accorded other minorities by Soviet law. Our latest calculations indicate that only one in six visa applications are being approved. So, while more Jews will leave the Soviet Union this year than any in the past, far more are also being refused.
