
Slowdown in Jews Leaving USSR

Concern is growing over the sharp drop in Jewish emigration from the Soviet Union. Only 15,000 Jews left the USSR during the first six months of this year as compared to 25,000 during the same period in 1979.

Most experts do not believe that the decrease in emigration is due to the increased East-West tensions as a result of the Soviet invasion of Afghanistan. In fact, it may be due to internal problems. Jewish emigration is encouraging others to want to leave, the Armenians, for example.

Whatever the reason, the drop in emigration is serious, especially as officially - sponsored anti - Semitism continues in the Soviet Union. The Soviet Union is violating international treaties it has signed, such as the Helsinki Accords, in preventing free emigrations.

This is why we welcome the promise of Max Kampleman, co - chairman of the Committee. on Security and Cooperation in Europe that the United States delegation will bring up Soviet Jewry at Madrid in November when the Helsinki Accords are reviewed. Not only emigration should be discussed. The illegal imprisonment of Anatoly Shcharansky and other Jewish activists as well as Soviet dissidents should also be on the agenda. The Soviet Union must be made to understand that if it wants to be treated as a legitimate member of the international community it must begin acting like one.







"Emblazoned with the emblem of the UN, and carrying the imprimatur of the Secretary - General, these later 'studies' are designed not only to give further currency to a completely misleading version of the history of the Arab - Israel conflict, but also to propagate bodus theories with regard to a number of complex legal issues connected with the Arab - Israel conflict.

Then putting the blame directly on the world organization, the eloquent Israeli Ambassador charged that, "by producing and disseminating these publications, the United Nations is serving the cause of international terror, not the cause of international peace. In the process, the UN has once again misused international funds, gravely compromised the integrity of the Secretariat and exposed the organization to severe and more than justified criticism.'


The girl in the yellow suit was walking quickly away.
