NEW YORK (WNS) -- The Anti-Defamation League of B'nai B'rith has charged that the Dynallectron Corporation, of McLean, Va., has been converting employees to the Moslem religion as a prerequisite for working in Saudi Arabia. The ADL claimed that the Fort Worth, Texas, branch of Dynallectron told helicopter pilots and crew being trained for fire prevention duty in Mecca during the pilgrimages that they would have to convert to Islam since non-Moslems are forbidden in the area.

IS WALDHEIM PRO-ARAB?

UNITED NATIONS (WNS) -- Yehuda Blum, Israel's Ambassador to the United Nations, charged here that the UN Secretariat has joined the anti-Israel position of the General Assembly and Security Council. He said that Secretary General Kurt Waldheim by speaking in favor of Palestinian statehood at an Arab League dinner recently had "squarely put himself on the side of our Arab opponents."

The Israel Mission to the UN had earlier issued a statement saying that Waldheim had "exceeded the limits of his office" by the statement which Israel charged was designed to ensure that the Secretary General

wins a third term when his present five - year term expires December 31, 1981.

Meanwhile, a spokesman for Waldheim denied that Waldheim had made a "call" for a Palestinian state. He said the Secretary General had spoken in "favor of Palestinian self - determination, including statehood."

He also said Waldheim had said the Palestine Liberation Organization "must participate" in Middle east negotiations and a solution of the Middle east crisis required Israeli withdrawal from occupied territories. The spokesman said Waldheim was expressing the statements in various UN resolutions.

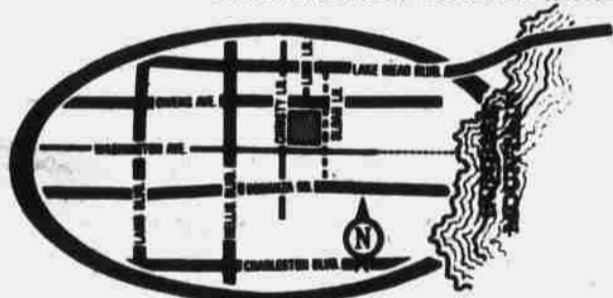

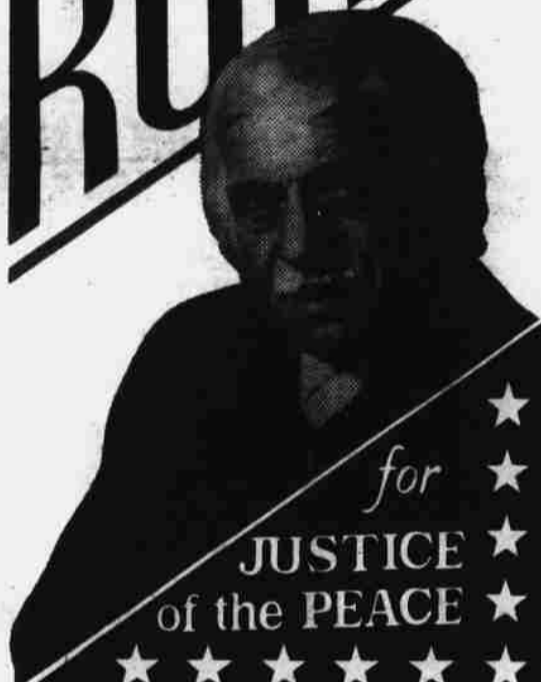
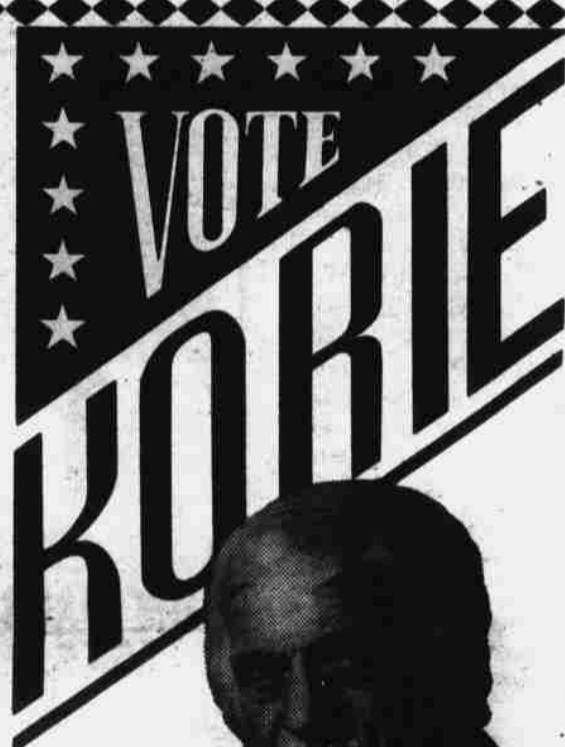
