

What The UN Must Be Told

UNITED NATIONS (WUP) -- Listening to the policy statements delivered by the delegation heads during the two - week run of the general debate of this 35th session, it seemed incredible to your correspondent how, most of them, indeed, the great majority, could have had the audacity to call upon Israel, first and foremost, to "recognize the legitimate national rights of the Palestinians including the right to establish a state of their own," and then only note that it is incumbent "upon the Palestinians to recognize Israel's right to exist within secure and recognized borders."

Worse still: all of them with a few exceptions, publicly approved the murderous PLO terrorists as the legitimate representatives of the Palestinians -- and such approval in their full knowledge of the fact that Arafat and his gang of assassins have as their main aim the destruction of the Jewish State, a full-fledged UN Member.

Even Carter's Muskie, in his reference to the Middle East, was somewhat vague. Although he stressed the importance of Resolution 242 and the value of the Camp David Accords, he spoke of the "current autonomy talks" as "having as their goal arriving at interim arrangements to establish full autonomy for the people of the West Bank and Gaza" and "after that," he emphasized, "the process will proceed to negotiations which will determine the final status of those areas."

PLO repetitive declarations interspersed here and there with words of 'comfort' and 'sympathy' for Israel -- in effect, "you, Israelis, too, have a right to exist!" -- was innerly aroused as he reflected the past two - thousand year history of the People of the Book and, as he closed his eyes, a vision flashed through his mind.

I see myself ascending the rostrum as the delegations, in surprise and wonder, look up. "Mr. President, and distinguished delegates," I open with a gesture of my hand pointing to the assembled representatives... "In the name of the people of the Hebrew Prophets, I come to you with a few words to say in reply to your statements about the Land of Israel and its people.

"Most of you are gathered here as the spokesmen of nations around the globe who through the centuries have persecuted, tortured, and expelled my people in murderous cruelty. You must bear the blame of what your forebears have done against the Jewish people. Few of you can claim innocence. May I mention the nation in this hall which gave birth to the bloody Crusades; those of you whose regimes sanctioned the Inquisitions, and you whose countries instigated pogroms, incited murderous riots in the ghettos.

"Is there a representative in this Hall who can rightly claim innocence for his country in acts of persecution of and discrimination against the Jewish people in history past and recent -- recent, indeed, the Hitlerian Holocaust, and who among you spoke out and cried violence in your knowledge of what took place in 'Dante's Inferno' gas chambers and crematoriums in 'Mit-

teleuropa?'

"You, whose nations, in murderous hate, have hunted, haunted and tortured my people century after century and confiscated their worldly goods, you, now have the gall to come here and espouse the cause of a new 'Hitler' and demand that the Israelis 'negotiate' with him and his henchmen -- a suicidal request. It shall never be. It shall never be, distinguished delegates, because the power of 'Destiny,' the 'Watchmen of Israel,' has decreed otherwise. The four wars against Israel, gentlemen, have proved that this Watchman is very much on the job. It would be in wisdom, therefore, on your part to take heed and act justly.
