## ISRAEL SHOWS PLANE TO MEXICO

WASH, (WNS) -- The **Carter** Administration which refused to allow Israel to sell its Israel Aircraft Industries (IAI) Kfir jet to Ecuador three years ago, now seems to be reversing itself. The State Department said that IAI will be allowed to show the plane to Mexico but would need U.S. permission be-fore the sale can go The Dethrough. did partment not confirm reports that Israel is also being allowed to show the plane to Venezuela and Columbia.

U.S. permission is needed for the sale of the Israeli - produced aircraft because it is powered by a U.S. made engine. State Department spokesman John Trattner, in confirming that Israel is being allowed to make the presentation in Mexico, said that IAI is showing the Kfir C-5, "a lower performance version of the more advanced C-2."

When the State Department objected to the sale of the Kfir to Ecuador it said

## ADL CONCERNED RACIST VOTES


NEW YORK (WNS) --The Anti - Defamation League of B'nai B'rith has expressed "deep concern" over the results of two Conraces in gressional which avowedly antiracists and Semitic candidates received a total of more than 75,000 votes in the Nov. 4 election. Nathan Perl-ADL's namutter tional director, was referring to two contests -- one in California's 43rd Congressional District where Ku Klux Klan leader Tom Metzger, running as a Democrat, received 35,000 votes, or 14 percent

other in Michigan's 15th C.D., where former Klansman and neo - Nazi Gerald Carlson won 53,000 votes on the GOP line, or about 32 percent. The Democratic Party had disavowed the candidacy of Metzger; the Republican Party

had disavowed Carlson. "While we are gratified that these two candidates were soundly rejected by the vast majority of the voters in their

districts as a whole," Perlmutter said, "we still find it of deep concern that 80 many Americans considered it acceptable to cast their votes for individuals who have openly proclaimed racist and anti-Semitic views." Their extremist views, he declared, "rather than offering any hope of solving social and economic problems, promise only fear, disruption and community polarization.'
