

**LEN HOWARD
NAMED GM OF RADIO STATIONS**



Steven Gold, President and chairman of the Board of Broadcast Associates, owners and operators of radio stations KVEG and KFM announced last week that Len Howard, Vice President of the firm has been appointed to the position of General Manager of the corporation's Las Vegas properties. In making the announcement, Gold, who vacates that position to devote more time to the corporations New Mexico and Texas radio stations, stated that the decision was unanimously agreed to by his Board of Directors. "We all felt that Len's knowledge of the Las Vegas media and his achievements during the 8 years since he helped found our company made it a very natural choice."

Howard first came to Southern Nevada in 1958 and for some eight years was one of Las Vegas' most popular radio personalities. He left in 1966 to assume the morning slot at New York City's, WPIX-FM. Returning to the local media in 1968, Len spent 4 years as Producer/Director for public T.V.'s channel 10. Then he joined with partners Steven Gold, Hank Thornley, Louis Wiener, and the late Dick Kannellis in forming Broadcast Associates of Nevada.

Howard is married to the former Theresa Golden of Point Loma, California. They have a 10 year old son, Dylan, who attends Helen J. Stewart School.

Along with the recent announcement, Broadcast Associates also named Jack Abell, as Sales Director of KFM and KVEG, the position vacated by Howard. Abell, former account executive for the company, is also one of the principles of the firm's El Paso (KSET AM & FM) and Albuquerque (KKJY & KXKS) properties.

**CHURCH WANTS
CLEAR POSITION
ON ISRAEL**

TEL AVIV (WNS) -- Sen. Frank Church (D. Idaho), departing chairman of the Senate Foreign Relations Committee, urged President-elect Ronald Reagan to make clear his support of Israel. Church who lost his re-election bid in November, said he did not doubt the sincerity of Reagan's pro-Israel statements.

"What concerns me are those other forces which are at work -- those who say on the one hand that our oil problems would be solved if the Israelis were not so intransigent and others who say that if the Israelis would cooperate we could get peace in the Middle East and that would lead to stability and an assured supply of oil," Church said in a radio interview.

"These people have increased their numbers. Their influence in Congress is larger than before," Church, who was here on a private visit, said Reagan should "lay out the blueprint of his own policy at the outset, making it clear, while his mandate is strong, to those of his own party who entertain those other ideas which they would like to call a more even-handed American policy, that if they want to press for that cause they will have him to deal with; that his policy is one of

full commitment on the part of the U.S. to the maintenance of a free and independent Israel and that we will not permit the Arab countries to use the oil weapon for the purpose of softening our ties with Israel or forming an alliance of convenience with the Arab states."

Church, a strong friend of Israel, will be replaced as chairman of the Foreign Relations Committee by Sen. Charles Percy (R. Ill.) who has publicly advocated a Palestinian State.

DEADLINE SET FOR JEWISH VICTIMS

NEW YORK (WNS) -- Jewish victims of Nazi persecution who were in no position to file claims under German indemnification laws may apply for a grant from a Hardship Fund established by the West German government, no later than Dec. 31 1981, the Conference on Jewish Material Claims against Germany announced here.

The grants will be made to Jewish victims who suffered damage to their health and are in straightened circumstances. The West German government plans to make DM 4000 million available for this purpose with individual payments limited to DM 5,000.
