cause today we shot down a MIG-25.

In Washington, State Department spokesman Dean Fischer said that the U.S. found the dogfight between Israeli and Syrian jets"disturbing and we hope there will be no repetitions. We continue to urge all involved to exercise maxi-mum restraint. Fischer refused to say whether the U.S. considered Israel's reconnaissance flights over Lebanon a violation of the cease-fire. He referred to an earlier statement that the flights were not armed actions.

The cease - fire was violated several times but Begin said he hoped it would last several weeks or even several months. Several Katyusha rockets were fired into the Christian enclave in south Lebanon. There was no response from the forces headed by Maj. Saad Haddad although some of his officers were reportedly demanding permission to return the fire. Israel has guaranteed that Haddad, whom it supports, would observe the cease - fire as long as the Palestinians did. The rockets were aimed at Kibbutz Misgav Am but fell short. The violation in the cease - fire is believed to be by the Popular Front for the Liberation of Palestine - General Command. Its leader Ahmed Jibril has denounced the cease - fire

Timor Goskell, a spokesman for the United Nations Interim Force in Lebanon (UNIFIL) said that the cease - fire signed by PLO leader Yasir Arafat was binding on all Palestinian groups including Jibril's Libyan - backed terrorists. Goskel noted that Arafat signed the agreement as "chief of al! the joint forces under the umbrella and the non - PLO umbrella which is the rejectionist front and the Lebanese nationalist faction. Goskell added, 'so he (Arafat) has committed himself on be-
