of the PLO go on, however, without any joint reaction from the international community, Israel cannot be expected to live by special rules or order. It cannot survive on 'moral victory' while terrorists' rockets rain on its soil. If that is the message it has transmitted, that may be more meaningful in the long run than the latest wave of high - minded piety it must now endure."

While the PLO terrorists in Lebanon ape the Nazis in their goal to annihilate the reborn Jewish State, the remnants of the actual Nazis are still around and right here in the United States. Colleague Charles R. Allen, Jr. along with Rochelle Saidel - Wolk, a well - known international correspondent for the JTA, have co - authored a significant 16 - page handbook entitled "Nazi War Criminals in America, Facts . . . Action." The work is revealing in that it discloses hitherto unknown facts about hundreds of Nazi war criminals, murderers moving about freely in many parts of the United States.

And no person is more qualified to produce such an historic work than Charles (Chuck) R. Allen, Jr., who was the first on the American scene to throw light on the "Nazi War Criminals Among Us" - an expose published by Jewish Currents in 1963. In this same year, his 320 - page book, "Heusinger of the Fourth Reich" was published by Marzani and Munsell. Indeed, no man on the U.S. scene has done more to expose U.S. - located Nazis than Allen. In this latest Allen - Wolk booklet, the following questions are asked and answered: Who are these Nazis? Where did they come from? How many are here now? Where do they live?

What are they accused of? Did the U.S. Government know they were here? What has Congress done about them? Who is prosecuting them? How many trials are there? What is happening in these trials? What resource materials are available?

"It is the springtime of 1981. A beautiful time of year. Everything is so full of life and beaming with color...The birds are singing, the bees are buzzing, all of nature's beauty revives itself and blooms in honor of the season... So chanted the 20 - year - old lovely daughter of two survivors of the Holocaust on the eve of their departure for Jerusalem to attend the world conference of survivors. But, Jacqueline Geizhals pauses and sees the year 1944. "Springtime was not so beautiful. At this time, then, my grandparents were being murdered by the Nazis." And Jacqueline queries: "Why were my relatives slaughtered? Why did my parents live through hell? Why do all my aunts and uncles have numbers on their arms? Why does my entire family have scars in their hearts? The answer is simple: merely because they are Jews.

"As the daughter of two survivors, I feel I inherited their experiences. I can relate to their suffering, the nightmares and the sorrow. I could feel the pain that they must have felt, not physically, but emotionally.

"But I am an American. I have my freedom and happiness. I am allowed to be Jew. I am allowed to celebrate Passover and Chanukah. I am allowed to pray for forgiveness on Yom Kippur and welcome in the New Year of Rosh Hashana. As a child, I went to Yeshiva and learned Jewish tradition and the Hebrew language. I learned of my heritage and culture. I learned to be a good Jew. I am proud to be a Jew and I am grateful that it doesn't threaten my life.

"I feel that being part of the second generation makes my existence a miracle." Jacqueline Geizhals continues to testify. "I often wonder how my parents both survived the holocaust and had my brothers and me. This makes me feel obliged to my religion. This makes me happy to be a Jew.

"In two weeks, I will fly to Israel for the World Gathering of Holocaust Survivors. I am hoping that I'll be able to meet some of the people my parents grew up with. I also hope that my parents find out that some people in their past are surprisingly alive. I want to learn from the people there, and try to under-

stand what they went through.

"I am overjoyed by the fact that this event will take place in Jerusalem -- the holiest place in the world. It is our country, our roots and without it the existence of the Jewish people could always be threatened as it was during World War II..."

Jacqueline returned from her Jerusalem experience greatly strengthened in her Torah-faith and in the hope of the eventual redemption of Israel and mankind.

Indeed, the N.Y. Post, in its editorial had set the record straight: Israel "cannot survive on 'moral victory' where terrorists' rockets rain on its soil," and Chuck Allen with Ms. Wolk have warned America to give no rest to those Nazis in our midst who played a role in the Holocaust that took the lives of the six million, among whom were Jacqueline Geizhals' grandparents. The hand of justice must fall upon them.

### U.S. RATIONALIZES AWACS SALE TO ARABS

WASH. (WNS) -- Defense Secretary Caspar Weinberger, appeared on ABC-TV's "Issues and Answers" recent program and said that the Administration is working out details on the use of intelligence information picked up by the AWACS reconnaissance aircraft the Administration proposes to sell to Saudi Arabia along with other sophisticated military hardware.

He stressed however that the AWACS are to be sold outright to the Saudis adding that the planes are not only to help the Saudis to prevent attacks on their oil wells but as a larger scaled plan that takes into account the overall interests of the Middle East, "specifically including the United States, specifically including Israel."

Senate Majority leader Howard Baker

(R. Tenn.), appeared on CBS-TV's "Face the Nation" program the same day and indicated that Israel too would benefit from the intelligence information gathered by the AWACS planes. "The actual crewing of the planes is not nearly as important as the staffing on the ground," he said. He added that the crew on the plane does not really know what information is being sent back to the base. He said what is important is "what access does the U.S. have or do the Israelis have."

Both Weinberger and Baker said the Administration would begin notification to Congress on the proposed sale after Congress returns from its summer recess in September as the State Department announced. According to Baker, this would mean that the final formal notification period would end in October or November. Baker said that no matter when the proposal goes to Congress, it still will be a "difficult fight."

On other issues, Weinberger said that the Administration still has not decided whether to resume shipment to Israel of 10 F-16's. State Department spokesman Dean Fishcer indicated that this decision will be made soon as the date approaches when four more F-16's are scheduled to be flown to Israel.

Weinberger implied that the decision will also include the first two of 15 F-15's which Israel has ordered.

He stressed that the U.S. policy in the Middle East is based on what best serves that area which he said included peace and prevention of Soviet expansion.
