

COURT REVERSES RULING

BONN (WNS) -- A lower court ruling which fined a 35-year-old teacher and a 32-year-old physician 800 marks for carrying anti-Nazi banners in Munich last September during a memorial ceremony for the victims of a synagogue bombing in Vienna that occurred several days earlier was reversed by a Munich appeals court, it was reported. The lower court ruling by a Bavarian State Prosecutor accused the two persons of abusing the right of assembly when the Judge ruled that the

two had failed to get written permission for their demonstration. The ruling by the appeals court, in reversing that decision found that the accused were participating in a legal public ceremony of mourning organized by the Munich authorities and the slogan on the banners they carried were consistent with the purpose of the ceremony and therefore, there was no demonstration in the technical sense and no prior permission was required. One of the banners read "Down With the Fascist Murder

Gang." The other criticized the Bavarian Interior Minister Gerold Tandler, for his claim that the neo-Nazi Wehrsportsgruppe Hoffman was "not really a dangerous organization" and that its members were "half mad" and not to be taken seriously. The group, which masqueraded as a sports club until it was barred by the authorities earlier this year is regarded as one of the most violent and dangerous of the neo-Nazi organizations that have cropped up

in the Federal Republic. According to an official report by the Bonn government, it cooperates with the Palestine Liberation Organization and scores of its members have received training in terrorist tactics by El Fatah in Lebanon.
