**BURGLARY REWARD: \$1,000**  
On Tuesday December 8, 1981 a residence on Plata Del Sol was broken into via the front door. Diamond rings sapphire rings gold chains a Kappa Alpha Psi fraternity ring, a man's 22' gold rope chain with gold medallion and six diamonds. The value of the entire loss was \$12,000.

**BURGLARY REWARD: \$1,000**  
On Saturday, December 12, 1981, a residence on Clayton Street in the Sunrise Mountain area was broken into by removing the kitchen door leading from the garage. The entire house was ransacked and the following items removed: a Century safe containing jewelry and \$800 cash, numerous shotguns, rifles, a color TV, and a wooden jewelry container. The total loss in this burglary was \$46,973.

**HIT & RUN REWARD: \$1,000**  
On Wednesday December 23, 1981 at 3:11 P.M., at Nellis Blvd. and Monroe Street, a 1981 Chevrolet driven by Lawrence Myers, 29 years of age, of Las Vegas was struck in the rear by another vehicle and knocked into oncoming traffic. Myers' vehicle struck a 1977 Chevrolet, driven by James Seech. The striking vehicle fled the accident scene. As a result of the accident, Lawrence Myers, his wife, his two small children and his mother-in-law, Mary Stephens of San Antonio Texas, were injured and taken to Nellis Air Force Base Hospital. Lawrence and his son Jeffery 2 years old, received minor injuries; daughter Jamie, 4 years old was treated for facial cuts and released. wife Theresa and Mary Stephens were admitted with their injuries. Witnesses at the scene reported that the striking vehicle was a black over blue large car.

Secret Witness will also pay cash rewards on crimes that are being planned. Also, cash rewards will be paid for crimes of a felony nature that are committed at the Lake Mead National Recreational Area or at Mt. Charleston and Lee Canyon Recreation Areas.
