**Call Secret Witness 386-3213**  
You Will Remain Anonymous

A reward of up to \$1,000 is offered by the Secret Witness Program in Reno, Nevada. On January 17, 1982, a 61 year - old white male was found stabbed to death east of Reno, Nevada, and his vehicle was taken by the suspect. The vehicle was later located by a Nevada Highway Patrolman approximately eight and one - half miles south of Lathrop Wells on January 19, 1982. The vehicle was parked twenty feet off of U.S. Highway 95 and was headed in a southerly direction. All indications are that the suspect abandoned the vehicle after it ran out of gas. The vehicle is described as a 1978 Pontiac Grand Prix, 2 - door, solid white in color, bearing Nevada License W39422. Anyone who may have picked up a hitch hiker in the area of Lathrop Wells between the 17th and 19th of January, or who may have had contact with the vehicle, should contact Secret Witness immediately. The suspect is described as appearing to be an Indian, with shoulder length straight dark hair, 5'7" tall, and about 155 pounds. The suspect was wearing a brown leather jacket, dirty white cords, brown cowboy boots, and may have been carrying a bag of some kind. Anyone having any information pertaining to the suspect is asked to either call the Secret Witness Hot Line in Las Vegas at 386 - 3213, or the Washoe County Sheriff's Department, Captain Mathews, Detective Division, Reno, Nevada, at 702 - 785 - 4652. Callers do not have to reveal their identities in giving the information or in collecting the cash reward.
