Numerous businesses of various types have been the victims of an extortionist starting May 30 and continuing to the present time. These businesses include fast food chains, gas stations, restaurant chains, supermarkets and department stores. The extortionist calls and demands money from the victim, threatening harm to the employees or customers if his demands are not met. In the instances where the victims have ignored the suspect's demands no retaliation has occurred.

Metro Police would like to be notified as soon as possible when an extortion call is received in order that prompt police action may be initiated. Secret Witness is offering a reward for information leading to the arrest of suspects in these extortions. BOMBING AND ARSON -- Cash Reward \$6,000, for arrest and indictment. \$1,000 from Secret Witness and \$5,000 from the insurance company. On April 15, 1982, a 1973 Cessna 421B (being number N209RP) was flown from Skyharbor Airport by the pilot with three passengers to the Tonapah Airport, Tonapah, Nevada. The aircraft landed at 7:01 P.M. on April 15, 1982. After being locked and left on the ramp for approximately three - and - one - half hours, an explosion occurred in the cabin area, tearing the aircraft in two, after which time it caught on fire and burned.
